## Scientific and technical cooperation Agreement with the United States of America

The Joint Standing Committee on Treaties, chaired by Andrew Southcott MP, will hold a public hearing in Canberra on Monday 14 August to examine the proposed Agreement between Australia and the United States of America (US) on scientific and technical cooperation.

The Agreement is expected to expand opportunities for mutually determined agency-to-agency collaboration for peaceful purposes, in science and technology between Australia and the US. Activities provided for under the Agreement include but are not limited to: joint research projects, training of scientists and technical experts, visits and exchanges of individual scientists, engineers and other appropriate personnel, exchanges of information on activities, policies, practices, laws and regulations concerning research and development.

"This Agreement will provide protection for Australian researchers when negotiating intellectual property issues in the US market. The Committee will examine the benefits and otherwise of the scientific and technical cooperation Agreement with the US," Dr Southcott said.

The Committee will also investigate amendments to the Convention on the Physical Protection of Nuclear Material and the Agreement between Australia and Japan on the Japanese Nuclear Fuel Cycle.

The public hearing will be held in **Committee Room 2R1, Parliament House**, **Canberra** on **Monday**, **14 August 2006** from **10.00 am**.
