DEAR SIRs.


IT IS THE SUBMISSION OF THE EXECUTIVE THAT THIS TREATY BE RATIFIED, WE SUPPORT TRADE WITH OTHER NATIONS AND THE NEED FOR INTERNATIONAL REGULATION OF THE INDUSTRY, PROVIDING THAT JOBS ARE PROTECTED AND THERE ARE NO COSTS TO THE AUSTRALIAN TAXPAYER. WE AGREE WITH THE OVERVIEW AND NATIONAL INTEREST SUMMARY. WE ALSO BELIEVE THAT IT IS IN THE BEST INTERESTS OF AUSTRALIAN WINE GROWERS TO HAVE INTERNATIONAL RECOGNITION OF WINE MAKING TECHNIQUES. THE EXECUTIVE WELCOME ANY TREATY THAT WILL PROTECT AND EXPAND ANY INDUSTRY IN AUSTRALIA. THE EXECUTIVE DO NOT SUPPORT THE DONATION OF \$ 500,000, OF TAXPAYERS MONEY TO SUPPORT THIS INDUSTRY. MONIES WOULD BE BETTER SPENT ON THE JOB CREATION ASPECTS OF THE INDUSTRY. REDUCTION OF TAXES TO AUSTRALIAN INDUSTRIES, AND THE INTRODUCTION OF A ONE PER CENT DEBIT TAX ON IMPORTS WOULD PROTECT THE FUTURE JOB MARKET IN AUSTRALIA. THROWING MONEY AT THE SYSTEM IS NOT THE ANSWER TO OUR CURRENT SITUATION. THE MORE TAXPAYERS THE MORE TAX REVENUE RAISED. OF COURSE THIS EXECUTIVE SUPPORT THE ABOLITION OF ALL TAXES AND A ONE PER CENT DEBIT TAX ON ALL TRANSACTIONS, ABOLITION OF THE AUSTRALIAN TAX OFFICE AND THE FEDERAL RESERVE BANK, AND ALL FINANCIAL CONTROL TO BE GIVEN TO TREASURY.
