DEAR SIRS.


IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THESE TREATIES BE RATIFIED, HOW  
EVER IT HAS COME TO THE ATTENTION OF THIS EXECUTIVE THAT THE AUSTRALIAN  
TAX OFFICE IS NOT A LEGAL ENTITY, THEREFOR CANNOT BE A PART OF THIS TREATY.  
THE AUSTRALIAN TAX OFFICE CANNOT APPEAR AS A PARTY IN THE HIGH COURT OF  
AUSTRALIA BECAUSE IT LACKS VALITY AS A LEGAL PERSONALITY, ( MOELIKER .V. CHAP  
MAN . B8 / 2008 ( 17 MAY 2000 ) H.C.A. P. 14 OF 45. JUSTICE CALLIHAN STATED THAT THE  
TAX OFFICE WAS NOT A LEGAL PERSONALITY. THE TAX OFFICE ADMIT THAT THEY ARE  
NOT A LEGAL ENTITY . A CONTRACT SUCH AS A TREATY IS NUL AND VOID IF THERE IS  
ANY ELEMENT OF ILLEGALITY , EVEN IF THERE IS NO CRIME COMMITTED. WHILE THIS  
EXECUTIVE SUPPORT EVERYONE PAYING TAXES , WE CANNOT SUPPORT THE USE OF AN  
ILLEGAL ENTITY BEING INVOLVED IN A TREATY, IT HAS ALWAYS BEEN OUR POLICY,  
THAT THE TAX OFFICE SHOULD BE ABOLISHED ALONG WITH THE FEDERAL RESERVE BANK  
AND THE TREASURY COLLECT A ONE PER CENT DEBIT TAX ON ALL TRANSACTIONS , BOTH  
IN AUSTRALIA, AND OFF FOREIGN NATIONALS , TAXES ARE KILLING AUSTRALIA . A ONE  
PER CENT DEBIT TAX WOULD REMOVE THE NEED FOR ALL OTHER TAXES , PLUS THERE  
WOULD BE NO NEED FOR A LARGE PUBLIC SERVICE , WE ALSO BELIEVE THAT ALL AID  
SUCH AS FOREIGN AID , FOREIGN DEBT , IMMIGRATION SHOULD CEASE , MONIES RAISED  
IN AUSTRALIA AS TAXES IS SUPPOSED TO BE USED TO RUN THE COUNRTY , GIVING THE  
MONEY AWAY IN FOREIGN AID IS FRAUDULENT , PROPPING UP THE BANKS WITH TAX

REVENUE IS FRAUDULENT, THE PEOPLE WHO ARE THE GOVERNMENT EXPECT ITS SERVANTS TO SERVE NOT TO GIVE AWAY TAXES TO THE INTERNATIONAL BANKING TRADITION, STARTED BY MAYER AMCHEL ROTHSCHILD IN 1760. THE PARLIAMENT DOES NOT HAVE A MANDATE TO GIVE AWAY MONIES THAT BELONG TO THE GOVERNMENT ( THE PEOPLE), WITHOUT A REFERENDUM. ALL BANKS SHOULD BE CONTROLLED BY TREASURY, WITH A STRICT CHARTER. WE HOPE THE ADVICE THAT WE OFFER IS TAKEN INTO CONSIDERATION REGARDING TAXATION & BANKING.
