## Submission by The Christmas Island Chamber of Commerce

To the Joint Standing Committee on the National Capital and External Territories

> Current Economic Development on Christmas Island

> > N.P. (Don) O'Donnell President 11<sup>th</sup> March 2003

- Mr Chairman/Deputy Chair, Members of the Committee, thank you for this opportunity to make a submission, which will deal mainly with current economic development as contributed by the small private sector of the Island but not Christmas Island Phosphates, which is the underlying constant to the economy.
- This Island, even more so, since the "Tampa" incident, is now very much directly involved in a "whole of Government" political process by Canberra. Specifically the fate and well being of this small community is decided by:

The Department of the Prime Minister.

The Departments of Defence, Finance, DIMIA, and the External Territories - and to a lesser extent by the Departments of Customs, Quarantine, Health and Education.

Policy decisions by the Federal Government and particularly by the Federal Cabinet, which affect the mainland population of nearly 20 million, have a range of checks and balances and alternatives to filter the social and economic impact on the community. e.g. State Governments, Industry, lobby groups, etc.

- Here on Christmas Island with it's permanent population of only 1500 1700 persons, approximately one third of which are children of various ages decisions by Cabinet related to this Island have a VERY DIRECT AND VERY IMMEDIATE IMPACT ON OUR SMALL FRAGILE ECONOMY and there are no checks and balances that the Chamber of Commerce is aware of, to mitigate any adverse effects of such decisions, other than by direct communication by telephone, fax or email to the Minister for External Territories, or by occasional face to face meetings.
- The Minister's visits are appreciated and are valuable but are mainly AFTER THE EVENT and when the Chamber of Commerce is given minimal hearing of 15 minutes, in a crowded, multi-organisational meeting to present the collective views of our current 56 members on a range of topics. One can ask,...."Is it enough time to have effective dialogue with the Minister?" ......The answer must be -"Obviously NOT".
- Up until 1990 the Island economy was wholly driven by the Mine and it's exports. There was no private enterprise sector and the Mine and Mine Union ran the Island.

- The Christmas Island Chamber of Commerce was started in 1991 and has had a slow but steady growth over the intervening years, but is now well placed with it's membership, and a positive bank balance, to reflect the views of the various Private Enterprises that now exist and are struggling to survive. By way of passing we are affiliated with the WA Chamber of Commerce and Industry, and we concentrate on Macro issues to improve the whole economy and bring benefit to the whole Community.
- On Wednesday, 5<sup>th</sup> March 2003, the Chamber convened a special meeting of <u>ALL</u> Business Interests on the Island to discuss the Government's decision to cancel the Walter Construction contract with DIMIA, which involved the construction of the multi-million dollar proposed Immigration Reception Processing Centre at North West Point.
- The formal announcement to create/construct the IRPC was made on 12 March 2002 12 months ago by the Minister for External Territories. It should be formally noted for the record that the Chamber had made it's position clear, over some two preceding years to the Government, that we strongly supported and endorsed the creation of decent accommodation and facilities for S.U.N.C.S, who were at that time arriving in ever increasing numbers in S.I.E.V.S.
- Our response to that announcement on 12<sup>th</sup> March 2002 was sober, measured and supportive, and we produced a document which I should like to present to this Joint Parliamentary Committee for the record, and which illustrates the collective views of Chamber members and the wider community's view point. (Appendix ONE.)
- At the meeting on 12<sup>th</sup> March 2002 the Community and particularly Business Interests, were advised by the Minister, that it would bring great economic benefit to the Island and that private enterprise and community members should seize the many opportunities that would flow from the project and to gear up the private investment business sector accordingly.

Well WE DID GEAR UP - IN OUR VARIED WAYS AND IN VARIOUS FINANCIAL AMOUNTS - and the Island economy looked solid up until mid December 2002.

- The shock announcement came on 19<sup>th</sup> February 2003, after weeks of rumours. The cancellation of the Walters Contract and "Deferment of the Project" for at least 9 months, has bewildered, dismayed and angered the business community. As I speak we are collecting statistics to support the fact that the private sector, small though it is, is vital to the well-being of this Island and it's future but has absolutely been derailed by this decision. It has had an immediate negative effect on business confidence in particular and the Community in general.
- Minister Tuckey stated that the decision was made because the IRPC project had developed a momentum all of it's own, between DIMIA and Walters Construction, and it was heading for a 100% blowout in cost, which was, of course, unacceptable use of taxpayers funds.
- The Chamber can accept this if TRUE, and we also recognise that the Cabinet decision cannot and will not be reversed. We were also proudly informed that the decision to cancel was an easy one to make *as it only took 3 minutes*!!
- The Chamber's response to this statement is that there could NOT have been a "SENSITIVITY ANALYSIS" made as to it's adverse effect on the Island Community, which was and is geared up to the IRPC Project.
- I should now like to formally present a second document to this Committee which lists a Summary of Construction and Infrastructure projects as at 21<sup>st</sup> February, some two days after the press release by Senator Minchin. (Appendix TWO)
- I should also like to formally present Chamber of Commerce correspondence dated 21<sup>st</sup> February 2003 to -

The Hon Philip Ruddock - DIMIA The Hon Wilson Tuckey - Regional Services, Territories & Local Government, and Senator the Hon Nick Minchin - Finance & Administration (Appendix THREE)

• An explanation or interpretation of the "Summary of Construction Projects" is quite simple. On or about the end of April 2003, the Island economy, already in decline from the 19<sup>th</sup> February announcement, will enter into a recession, not seen or experienced since the sudden closure of the Casino Resort in <u>1998.</u>

- The correspondence to the three Ministers is self evident, in that we ask various questions and have made some pro-active suggestions to keep the Island economy going. As yet we have had <u>no responses.</u>
- By way of further comment, the current assessment by many thoughtful members of the Chamber and residents of some standing, is that the deferment; or cancellation of the Walter Contract is the FIRST STEP to a full cancellation of the IRPC Project. Consider -
  - A) The Developed Construction Village with a capacity of 350 workers to be mothballed.
  - B) The Development of Permanent Staff Quarters for approximately 170 persons currently mothballed.
  - C) The current rebuilt Detention Centre soon to be mothballed.
  - D) The construction of pumping station, pipelines and water tank storage for IRPC now idle.

Can one wonder at the loss of confidence?

- The adverse flow-on effects are many, and will affect the entire community and all investments by private enterprise, e.g.
  - Import cargo volumes by sea reduced and loss of profitability to the shipper and stevedoring operations.
  - Idle capacity in container transport loss of earnings, profit and cash flow after making heavy investments.
  - Idle capacity in National Jet Systems leading to an inevitable increase in Government subsidy and a re-scheduling and reduction of frequency of service, and the Jakarta Air Service placed in financial jeopardy.
  - Lower turnover of high stock inventories, already made by retail outlets resulting in unprofitable trading.

- Low and decreasing levels of occupancy in recently provided NON Government accommodation with serious loss on investment outlay.
- Building and construction lay-offs of men and machines brought to the Island to cater for the project demand resulting in rapid growth of unemployment.
- Downturn in the service sectors of communications, entertainment, food outlets, hire cars, petrol and diesel volume sales, tourism and real estate values a complete disaster for small business.
- Decrease in revenue to Power and Water Utilities caused by a decline in demand.

In short, a cash flow crisis for Island business is occurring with activity and turnover down 40% to 90% dependent on the sector, and despite a record private sector investment of \$22.75 million across a wide range of enterprises as detailed in Appendix Four.

• In conclusion, Members of this Committee, the Chamber of Commerce are actively promoting an acceleration of infrastructure projects, as detailed in our correspondence to the three Ministers covering Territories, DIMIA, and Finance to prevent a severe recession commencing in April, and already gathering momentum, and in addition would like to draw your attention to the Parliamentary Standing Committee on Public Works published in March 2002 - concerning the upgrade of the Christmas Island Airport at a cost stated to be \$51.3 million. Page 18 - para 3125, "Conclusions and Recommendations" - very clearly states:-

"The Committee is of the view, that irrespective of APSC proceeding, an upgraded Airport for Christmas Island would help decrease the isolation of the Christmas Island Community by improving it's Air Services ......" etc, and goes on to state in Recommendation 5 "....the proposed common use infrastructure project proceed pending approval of the draft Environmental Impact Statement, and the fulfillment of the recommendation made in this Report." Page 7 para 2.8 - NEEDS AND PUBLIC VALUE - the Administrator of Christmas Island, Mr William Taylor, in response to a question about the need for the upgraded Airport if the APSC does not proceed - responded that ... "Irrespective of the APSC there is a requirement for the upgrade on safety grounds."

In short, the Island desperately needs this project to start as quickly as possible. The plans are made, the finance is allocated, but this vital Public Works Project is held up by DOTARS, and Finance - conditional on the APSC proceeding.

We are NOT an Island society of mendicants dependent or depending on Government handouts, but rather we are genuinely trying to build a vibrant investment climate in partnership with Government - BUT IT IS NOT WORKING and there really is NO marriage of private investment interests, or sensitivity between Canberra and the Island, when a fundamental decision can be made by the Government, in three minutes, which slams the private sector and the whole community into immediate recession.

Until conditions improve, any Government Policy plans to privatise Health, Power, the Port, and the Airport should be deferred in line with the costly accommodation infrastructure also deferred.

### CHAMBER OF COMMERCE – EXTRACT FROM MINUTES.

Regular monthly meeting held 19 March 2002.

At this meeting of the Chamber, the subject of the MINISTERIAL announcement was an AGENDA ITEM for general discussion.

It was resolved by that meeting that:-

- a) The C.I. Chamber of Commerce fully endorsed the decision to build the Centre on this Island.
- b) That a letter be sent to MINISTERS TUCKEY and RUDDOCK stating the full support of the Chamber, and
- c) That a working group of Chamber members be set up to suggest ideas that could influence the design, concept, and social functions of the centre such ideas to be formulated, and sent to Canberra as soon as possible.

Meeting of the working group were held on 20<sup>th</sup> and 27<sup>th</sup> March 2002. At meeting held on the 27<sup>th</sup> March – the President of the Chamber raised the status of the group to that of a SUB-COMMITTEE to:-

- a) Examine thoughts, suggestions and opinions against a first working draft: and
- b) To test those thoughts, suggestions etc. against RESEARCH material presented to the sub-committee.

- It must be stated that it is NOT the intention of this sub-committee to "reinvent the wheel", as we know little of the problems of Detention Centre organization, administration and range of complex problems.
- Input to the report has been received by members, and other concerned thinking citizens NOT members of the Chamber, but gladly accepted as worthy of inclusion in this presentation.

### LEISURE - Too much boredom - trouble!!

Centre to have structural activities programme, graded to account for security groupings.

Encourage voluntary work, with Island Green Corp. to develop COMMUNITY projects ie. forest board walks; elimination of introduced weeds; clean up projects etc. Beautify Centre with grassed areas and colourful native plants.

### LOGISTICS

By sea – Provided that at least two container feeder vessels are on a regular schedule, there is now on Island, cool and refrigeration capacity of approx. 220 m3. This should be sufficient in the short/medium term.

By air – Merpati 737 flights can be increased to daily flights, ex JAKARTA, and can carry three tonnes of fresh fruit and vegetables plus dairy products and one tonne of general cargo on each flight. To increase to daily flights, support with passenger traffic will be needed from DIMIA in particular and government in general. Note - Cost of the flight from Melbourne, or Sydney to Jakarta, thence Christmas Island is up to 160% less using Qantas and Meroati, than across Australia to Perth, thence onto Christmas Island via Cocos. Huge savings in airfares can be made.

### M – MILITARY

Naval presence to be maintained for the short term, until the centre NEW INITIATIVE is established and routines are in place. It is suggested that without a naval presence, illegal boat persons (SUNC's) will again flood the Island.

Naval personal on long term patrol duties <u>must</u> be given greater and more frequent periods of time ashore on the Island. Good moral on naval vessels must be maintained.

Establish small army presence as security for any possible potential disturbance.

### **MOVEMENTS**

# Immigration Reception and Processing Centre (IRPC) - Christmas Island

The announcement by your Ministerial colleagues, Senator Minchin and Minister Ruddock on the 19<sup>th</sup> February 2003 in regards to cancellation of the existing contract with Walter Construction Group has been received by members of the Chamber of Commerce firstly with dismay, followed by anger and disbelief.

Although not confirmed in writing, it has been verbally conveyed to owner operators and employees at the North West site, that all works will cease within 6 weeks. Many of the these large and small operators **have** taken up the challenge as voiced a number of times by yourself and your Ministerial colleagues during visits to the Island and become part of this "great opportunity". Concern deepens to despair as there is no other alternative works in progress on Christmas Island. Unlike on the mainland, there is no opportunity to diversify or move to other announced projects as they also have not moved beyond the planning stage.

The whole business community across the Island is known to have made substantial economic and personal commitments to be part of this "great opportunity" and other projects announced by the Government over the last 18 months. The effect of a major delay in the construction phase of a project of this size on our small community is going to have a severe impact on the Island economy. Many people, employers and employees are heading for financial disaster whilst these delays continue.

Members of the Chamber have requested that the following be placed before you and are seeking your replies while you are on Christmas Island. We are aware that your schedule is tight however we feel that the needs of the people must be given some priority under the circumstances and that answers to these questions are critical to the Islanders and their futures. We are entitled to receive definitive answers to the questions below in order for the business community to satisfy the demands that will be made by financial institutions, banks, etc and creditors. They must be given the ability to manage what for many of us will be acute financial circumstances that you and other Ministers have created.

Q1 Will the scaled down 800 person purpose built IRPC as detailed in the Government News Release dated 19 February 2003 be a new permanent construction at North West Point, Christmas Island or a de-mountable facility?

Q2 What is the latest start and completion dates of the construction project?

Q3 With major delays now disclosed and with the ongoing financial hardship that will result to the whole Christmas Island Community will you immediately instigate with Minister Philip Ruddock the re-location of offshore displaced persons currently located on the Australian Mainland, Manus and Nauru Islands to the temporary facility at Phosphate Hill, Christmas Island?

Q4 With delays and changes to the IRPC project resulting in financial difficulties to a wide range of the business community persons, will the Government be establishing a compensation package and a process for the lodgment of claims against Government Departments?

Q5 Will the Minister on behalf of DOTaRS release by 31 March 2003 the infrastructure plans with financial commitments for Christmas Island for the next 3 - 5 years?

Q6 To boost tourism and create economic flow-on to businesses on the Island, will the Government provide special assistance to maintain the Northern route to Asia?

If you recall, members of the Chamber during your initial visit in 2001 to discuss this project, strongly and unanimously supported the Government in the establishment of the IRPC on Christmas Island both in writing and by verbal communication. # Immigration Reception and Processing Centre (IRPC) - Christmas Island

The announcement by your Ministerial colleagues, Senator Minchin and Minister Ruddock on the 19<sup>th</sup> February 2003 in regards to cancellation of the existing contract with Walter Construction Group has been received by members of the Chamber of Commerce firstly with dismay, followed by anger and disbelief.

Although not confirmed in writing, it has been verbally conveyed to owner operators and employees at the North West site, that all works will cease within 6 weeks. Many of the these large and small operators **have** taken up the challenge as voiced a number of times by yourself and your Ministerial colleagues during visits to the Island and become part of this "great opportunity". Concern deepens to despair as there is no other alternative works in progress on Christmas Island. Unlike on the mainland, there is no opportunity to diversify or move to other announced projects as they also have not moved beyond the planning stage.

The whole business community across the Island is known to have made substantial economic and personal commitments to be part of this "great opportunity" and other projects announced by the Government over the last 18 months. The effect of a major delay in the construction phase of a project of this size on our small community is going to have a severe impact on the Island economy. Many people, employers and employees are heading for financial disaster whilst these delays continue.

Members of the Chamber have requested that the following be placed before you and are seeking your replies while you are on Christmas Island. We are aware that your schedule is tight however we feel that the needs of the people must be given some priority under the circumstances and that answers to these questions are critical to the Islanders and their futures. We are entitled to receive definitive answers to the questions below in order for the business community to satisfy the demands that will be made by financial institutions, banks, etc and creditors. They must be given the ability to manage what for many of us will be acute financial circumstances that you and other Ministers have created.

Q1 Will the scaled down 800 person purpose built IRPC as detailed in the Government News Release dated 19 February 2003 be a new permanent construction at North West Point, Christmas Island or a de-mountable facility?

Q2. What is the latest start and completion dates of the construction project?

Q3 With major delays now disclosed and with the ongoing financial hardship that will result to the whole Christmas Island Community will you immediately instigate with Minister Philip Ruddock the re-location of offshore displaced persons currently located on the Australian Mainland, Manus and Nauru Islands to the temporary facility at Phosphate Hill, Christmas Island?

Q4 With delays and changes to the IRPC project resulting in financial difficulties to a wide range of the business community persons, will the Government be establishing a compensation package and a process for the lodgment of claims against Government Departments?

Q5 Will the Minister on behalf of DOTaRS release by 31 March 2003 the infrastructure plans with financial commitments for Christmas Island for the next 3 - 5 years?

Q6 To boost tourism and create economic flow-on to businesses on the Island, will the Government provide special assistance to maintain the Northern route to Asia?

If you recall, members of the Chamber during your initial visit in 2001 to discuss this project, strongly and unanimously supported the Government in the establishment of the IRPC on Christmas Island both in writing and by verbal communication. Bearing in mind the subsequent benefits that would eventually flow to the Island Community, we continued to support the Government in the establishment of diverse commercial, industrial and professional infrastructure on Christmas Island.

Other projects that could proceed during 2003 to ensure our community does not go into a severe economic decline are as follows;

### 1. Linkwater Road

The proposed works are necessary in order to facilitate the establishment of the port facility at Mar Chor Nui Nui – Without this road, this port facility is not usable – Heavy traffic will destroy the existing road through the Settlement residential area. We understand that all documentation and designs have been completed for this road, however at the last minute Softstar Holdings have objected to the design.

We ask that this issue be resolved quickly to permit the project to proceed.

### 2. Airport Extension Project

We are aware that the main works on the airport extension may be tied to other projects – eg APSC. Some parts of this project are immediately necessary, including the airport apron and surrounding parking areas. Some of this work is required to facilitate the current hangar and maintenance workshop being constructed for the Australian Navy helicopter facility. We ask that you consider commencing construction on this segment of the airport extension project as soon as possible.

### 3. Community Recreational and Sporting Complex

We understand that you already have requested GHD to prepare a design for this facility, and ask that this project be fast-tracked to commence as early as possible in 2003 to maintain employment and to assist local businesses to maintain reasonable activity.

### 4. Existing Detention Centre

As far as we are aware, the Immigration Department are proposing to dispatch the balance cf refugees held at this centre to other centres, dismiss or transfer all staff, and "moth-ball" the facility. With the deferment of the IRPC project the potential closure of the temporary facility, the roll-on effect to the Island economy will be totally disastrous for Christmas Island. It will cause the cancellation of the Northern charter, the closure and departure of many businesses and a significant reduction in the Island population.

We ask you to apply every possible effort to have this decision reversed, and that refugees are transferred from other overseas and mainland centres to Christmas Island to maintain this important industry to our economy.

We would appreciate your urgent reply on these matters.

We understand that you already have requested GHD to prepare a design for this facility, and ask that this project be fast-tracked to commence as early as possible in 2003 to maintain employment and to assist local businesses to maintain reasonable activity.

### 4. Existing Detention Centre

As far as we are aware, the Immigration Department are proposing to dispatch the balance of refugees held at this centre to other centres, dismiss or transfer all staff, and "moth-ball" the facility. With the deferment of the IRPC project the potential closure of the temporary facility, the roll-on effect to the Island economy will be totally disastrous for Christmas Island. It will cause the cancellation of the Northern charter, the closure and departure of many businesses and a significant reduction in the Island population.

We ask you to apply every possible effort to have this decision reversed, and that refugees are transferred from other overseas and mainland centres to Christmas Island to maintain this important industry to our economy.

We would appreciate your urgent reply on these matters.
