## BACKGROUND

I believe that what the Federal Government is trying to do is not a 'new thing' - it was the intention of the law when the N.I. Act was being considered and became the law when the N.I. Act was passed by Australian Parliament.

Citizenship was originally stated and became the law until 1985 when the 'Commonwealth' at the request of Norfolk Island amended it in 1985.

Australian citizenship was provided for in clause 38 (a) of the N.I. Act 1979 '*in 1979*' and remained until 1985 when by instrument #65 of 1985 (Commonwealth) it was repealed.
