EMPLOYMENT CONCILIATION BOARD

Governing Legislation: Employment Act 1988

Membership: Three Members

Term of Membership: Not less than 2 years but not more than 3 years but may be reappointed.

Qualifications for Membership:

A person has relevant qualifications or experience for the purposes of appointment to the Employment Conciliation Board if the person -

- (a) has had substantial experience in industry, commerce, industrial relations or the service of a government or authority of a government;
- (b) has been a member of the Public Service Board
- (c) has been a Magistrate, or has held judicial office of a similar kind in a place other than Norfolk Island;
- (d) is or has been entitled to practise law in Norfolk Island, or in a State, Territory or New Zealand; or
- (e) has obtained a degree of a university or an educational qualification of a similar standard in the field of law, economics, industrial relations or some other field of study considered by the executive member to have substantial relevance to the functions of the Board.

Functions of the Board

The functions of the Board are to inquire into and resolve matters in respect of which powers and functions are conferred on the Board by the Act.

In particular, the functions of the Board are to consider matters brought before it in relation to employment.

Power of the Board

The Board has the power to do all things that are necessary or convenient to be done for or in connection with or incidental to the exercise of its powers and the performance of its functions

IMMIGRATION COMMITTEE

Governing Legislation: Immigration Act 1980

Membership: Not less than 3 but no more than 5 members, at least one but no more than 2 of whom shall be Members of the Legislative Assembly and all of whom shall be residents.

Term of Membership: Two years but can be re-appointed

Functions of Committee

The Functions of the Committee are to furnish reports to the executive member

- (a) as provided by section 19 of the Act, with respect to applications for the grant of general entry permits;
- (b) as provided by section 32 of the Act, with respect to applications for persons to be declared to be residents of Norfolk Island; and
- (c) with respect to any other matter which the executive member refers to the Committee concerning his powers or functions under this Act or that otherwise relates to the operation of the Act.

The Committee may offer advice to the executive member with respect to any matter which, in its opinion, relates to -

- (a) the grant of permits;
- (b) immigration to Norfolk Island; or
- (c) the declaration of persons to be residents of Norfolk Island, or otherwise relates to the operation of the Act.

LEGAL AID ADVISORY COMMITTEE

Governing Legislation: Legal Aid Act 1995

Membership: Three members

Term of Membership: Two years but may be re-appointed

Functions of Committee

The functions of the Committee are to make recommendations to the executive member concerning -

- (a) whether in relation to an application for legal assistance referred to the Committee by the executive member, such assistance should be granted; and
- (b) the provision of legal assistance on Norfolk Island; and
- (c) measures to improve legal education and access to legal services on Norfolk Island; and

(d) such other matters relating to legal assistance and legal education as are referred to the Committee by the executive member.

LIQUOR LICENSING BOARD

Governing Legislation: Liquor Act 1960

Membership: Three Members Term of Membership: Three years but can be re-appointed

- (b) Renew, transfer or remove a licence;
- (c) Suspend or cancel a licence or conditional certificate;

MUSEUM TRUST

Governing Legislation: Museum Trust Act 1987

- (h) to encourage the provision of means for addressing complaints about broadcasting services; and
- (i) to ensure that the providers of commercial, community, or non-government broadcasting services are responsive to the need for a fair and accurate cover of matters of public interest and for appropriate coverage of matters of local significance.

- (f) to advertise Norfolk Island as a tourist resort, on television or by any other means of communication; and
- (g) to collect and supply, with or without charge, information concerning Norfolk Island; and
- (h) to provide assistance to travel agents, transport operators and other appropriate bodies or persons in arranging travel, accommodation or other services or facilities for people visiting Norfolk Island; and
- (j) to carry on the business of travel agent or transport operator; and
- (k) to arrange or conduct tours to or from Norfolk Island, with or without another place as an intermediate destination; and
- (l) to carry on the business of providing accommodation, meals, refreshments, goods and other services and facilities for persons visiting Norfolk Island; and
- (m)to operate tourist bureaux; and
- (n) to accept gifts and contributions for the purposes of the Bureau; and
- (o) to --
 - (a) carry out all or any of its functions; or
 - (b) to exercise all or any of its powers,
 - either in Norfolk Island or elsewhere; and
- (p) to do all things necessary or ancillary to its powers.

Functions
