## Balancing work and family

Australian women are having fewer children, with many delaying starting their families. As a result we have a declining birth rate. What disincentives exist to starting families? What are the factors that affect parents' choices to undertake paid work? How can an environment more conducive to having families be achieved?

The House of Representatives Standing Committee on Family and Human Services has begun a public inquiry into the problems encountered in balancing work and family responsibilities. The committee has invited public submissions on:

- the financial, career and social disincentives to starting families;
- making it easier for parents who so wish to return to the paid workforce; and
- the impact of taxation and other matters on families in the choices they make in balancing work and family life.

## National inquiry into teacher education

How well prepared are our teachers for the classroom? The Minister for Education has asked the House of Representatives Education Committee to conduct a national inquiry into the quality and adequacy of teacher training courses in Australia. The House Education Committee will examine the scope, suitability, organisation, resourcing and delivery of teacher training courses in Australia's public and private universities. It will examine the preparedness of graduates to meet the current and future demands of teaching in Australia's schools. The expansive terms of reference identify a number of specific issues that will be examined including:

- the criteria used to select students for teacher training courses;
- the structure of courses and teaching methods used;
- how teachers are prepared to teach reading and numeracy;
- how teachers are prepared to deal with bullying and disruptive students and dysfunctional families;
- ongoing professional learning for teachers already in the workforce; and the
- adequacy of funding of teacher training courses by university administrations.
