To be eligible, customers must receive a regular salary into their Commonwealth Bank account and show a good payment record on existing Commonwealth Bank facilities. Other risk criteria and exclusions may apply.

A conditional offer is not an extension of credit. A customer who receives the offer can apply for credit but must pass a full servicing assessment before credit is extended.
