Cbus has the naming rights to the Robina Stadium on the Gold Coast. The venue is known as Cbus Super Stadium. The naming rights deal was agreed in 2014 after a competitive tender conducted by Stadiums Queensland. A feature of the rights was the inclusion of a corporate box. The box has been used 13 times across the 6 years, including for business development and member education programmes, some of which focus on young members. Except for one boardroom event which was hosted at Cbus Stadium on the 20 June 2016, the references above to venue hire at Cbus Super Stadium refers to the use of the corporate box. Following the amendments to s 68A of the *Superannuation Industry* (Supervision) Act 1993 (Cth) on 5 April 2019 and the introduction of RG68A, the corporate box is not used for entertaining employers and prospective employers.
