- 1. Indonesia's commitments on categories of natural persons and its respective conditions and limitations for the temporary entry and temporary stay, including length of stay, are made in accordance with Article 9.5 (Schedules of Specific Commitments on Temporary Movement of Natural Persons).
- 2. The Horizontal Schedule below shall be interpreted in the light of Chapter 9 (Temporary Movement of Natural Persons). Natural persons of another Party that fall under the categories specified in the Horizontal Schedule are permitted to enter and stay in Indonesia subject to its applicable conditions and limitations.
- Where natural persons of another Party in categories permitted to enter and stay with respect to sectors listed in Appendix IVA (Sector-Specific Commitments), all conditions and limitations specified in each category of the Horizontal Schedule shall also apply, unless otherwise specified.
- 4. For greater certainty, Indonesia reserves the right to adopt or maintain any measures with respect to categories of natural persons other than those categories listed in this Horizontal Schedule.
