- (a) allow the legislation which may bring an Aboriginal and Torres Strait Islander Commission (ATSIC) into existence to lie before Parliament for at least six months;
- (b) more actively involve Aboriginal people and groups in consultation and in possible amendment of this legislation; and
- (c) reinstate the Aboriginal Development Commission (ADC) as it was constituted before the recent dismissal of commissioners, and continue to fund all current Federal Aboriginal bodies until ATSIC comes into operation, or until other proposals which have widespread Aboriginal support are implemented.

Moved (Senator Coulter) and agreed to 24/5/88.

Australia's Defence Forces - The requirement for the Federal Government to initiate immediately such restructuring of Australia's Defence Forces as will -

- (a) address all dimensions of the crises in defence effectiveness, morale and economics;
- (b) bring Australia to a position of Armed Neutrality but with a modern, competent, mobile and flexible Defence force able to protect our national integrity if under attack;
- (c) maintain and demonstrate a strong nuclear free stance;
- (d) integrate our defence and other forces into potent dual civil/military roles and structures such as to render them of immediate relevance and visibility through such roles as fire fighting, emergency services, rescue, coastal patrol, drug surveillance and others; and
- (e) support trends away from vast expenditures on armaments which reflect assumption of global conflict and thereby increase the likelihood of such conflicts.

Moved (Senator McLean). Senator Newman (at the request of Senator Chaney) moved an amendment to the motion:

Leave out all words after "urgency", insert "The need to reaffirm that essential elements of Australia's defence policies include:

- (a) the maintenance of our systems of alliances, particularly the alliance with the United States; and
- (b) rejection of unilateralist approaches to complex issues of disarmament and arms control".

Amendment agreed to and motion, as amended, agreed to 28/11/88.

Drug supply - The requirement for the Federal Government as a matter of urgency to supply injectible drugs to intra-venous drug users so as to:

1. Make these drugs more safely available.
2. Limit the spread of AIDS.
3. Reduce both major and minor crime.
4. Bring drug users into contact with treatment and counselling services.

Moved (Senator Coulter) and negatived (division) 25/11/88.

Failure of Labor's economic and social policies - The failure of Labor's economic and social policies which have increased the burdens on all Australian families and the need for the Government to adopt policies which provide incentive for individuals, strengthen the family and encourage the growth of private enterprise in Australia. Moved (Senator Chaney) and negatived (division) 5/12/88.

Minister for Defence - The need for the Minister for Defence to be removed from his portfolio given that over the last three years he has presided over the decline in morale of the defence force indicated by low recruitment, high wastage of personnel, and an apparent inability to control senior departmental officers, thereby losing the confidence of members of the Defence Force, the Parliament and the public, and as a result of all these factors precipitating an unprecedented crisis in Australia's defence capacity. Moved (Senator McLean) and agreed to 27/4/88.

National Aboriginal and Islander Health Organisation - The need for the Prime Minister to dismiss the Minister for Aboriginal Affairs because of his misleading of Parliament over the question of funding for the National Aboriginal and Islander Health Organisation and the subsequent attempts to falsify the record in defiance of all accepted public service procedures. Moved (Senator Chaney) and negatived (division) 6/12/88.

Victorian building industry - The actions of building industry unions in Victoria, supported by the Victorian Labor Government, in victimising and harassing self-employed building trades subcontractors working on industrial and commercial building sites, for whom such work was arranged by the labour hire agency Troubleshooters Available, and the necessity for the Hawke Government to take urgent action to assist in preventing further disruption. Moved (Senator Short) and negatived (division) 19/10/88.
