

Business conducted in the Senate

Types of business in the Senate

Business of the Senate includes disallowance motions, orders of the day for the presentation of committee reports, motions to refer matters to standing committees, motions for leave of absence to a senator and motions concerning the qualification of a senator. It has precedence over government and general business for the day on which it is listed.

Government business is business initiated by a minister. It includes all debate on government bills, procedural motions and ministerial statements. Government business takes precedence over general business except for a period of 2½ hours on Thursdays.

General business is all other business initiated by senators who are not ministers. It includes motions to take note of answers, notices of motion, consideration of committee reports and government responses and matters of public interest. General business takes precedence over government business on Thursdays as described above.


Questions include question time and additional answers given by ministers at the end of question time.

Urgency motions and matters of public importance (MPIs) may be proposed by senators on any sitting day pursuant to standing order 75. At the conclusion of the debate there is no vote taken on the substantive issue of the matter or motion. However, in the case of urgency motions, a procedural vote is taken as to whether the matter is considered urgent or not.

Other business includes prayers, petitions, postponements and ceremonial business.



Total time, by type of business, 1999




Percentage of time, by type of business, 1999


and breakdown of government business




Proportion of time spent according to type of business 1991 to 1999




Number of sitting days: 1990 to 1999



Average length of sitting day 1990 to 1999




Total Senate sitting time: 1990 to 1999




Average number of questions without notice asked: 1990 to 1999
