Please list the steps you have taken to assure yourself you have not acquired citizenship of another country by descent, marriage or other means.

With both parents born in Australia and three of four grandparents born in Australia, the only possibility of inherited citizenship would lie with my maternal grandfather who was born in the UK in 1902, emigrated to Australia in 1924 and died in Australia in 1981.
While never having reason to believe I inherited British citizenship from my maternal grandfather, I nevertheless took steps to assure myself in this regard.
Legal advice confirmed I derive no claim to British Citizenship and advice from the British Consulate based on their standard assessment tool confirmed the same. Furthermore, I wrote to the British Home Office in the UK whose reply also reiterated the same: " I can confirm that you derive no claim to British citizenship based on your mother's father having been born in the UK" (Mr Ian Walker, Deputy Chief Case Worker, Nationality Team, UK Visas & Immigration).
