Please list the steps you have taken to assure yourself you have not acquired citizenship of another country by descent, marriage or other means.

Under the *British Nationality Act 1948*, a person born between 1949 and 1983 could inherit British citizenship only from his or her father (see section 5). Therefore, even assuming my mother was a British citizen, I cannot have inherited that citizenship. I understand that the *British Nationality Act 1981* (being the Act which replaced the 1948 Act) was amended in 2003 to allow for the registration of persons born to British mothers before 1 January 1983 as British citizens. However, this requires a positive act of application. I have never made such an application to be registered as a British citizen, and therefore could not have acquired British citizenship from my mother.

Further, under that Act, the general rule was that no person born between 1949 and 1983 could become a British citizen by descent from a parent who was himself a citizen by descent only (see section 5). The limited exceptions to that rule are not relevant to me. Therefore, even assuming my mother was somehow a British citizen by descent, I cannot myself have inherited that citizenship.
