

Dear Mrs. Wicks,

This letter is in response to your enquiry concerning Canadian citizenship. You have explained to our offices that you are an Australian citizen married to a Canadian citizen, but that you have never resided in Canada nor applied for Canadian permanent residency or Canadian citizenship.

Marriage to a Canadian citizen does not give you Canadian citizenship. You must first apply for and receive permanent resident status. Then you must apply for Canadian citizenship and meet the same requirements as any other person seeking Canadian citizenship.

Based on the information you have provided, you do not have any entitlement or claim to Canadian citizenship, and would have to apply for citizenship through the regular immigration channels.
