	I understand from information provided by the Lebanese Embassy that citizenship is not automatic but needs to be registered and applied for – which to the best of my knowledge has never been sought by my parents or grandparents.					
	My grandfather served in the home defence corp in WW1 and on the Cloncurry Shire Council.					
My father served in the Australian military. He was a Captain in the Army whe broke out. He later served as a Federal Member of Parliament for 24 years and those years he was appointed Minister for the Army.						
	By the very nature of their military and civic service, as I understand it, neither could have had any allegiance to another country.
