Visiting the Bourke and Brewarrina academies was further affirmation to me that the Governments, both State and Federal, should continue to support the Foundation.

The boys and community attitude towards the boys future is one of promise and blue sky. The boys all have long term plans and goals for their future which would not exist without the Clontarf academies in their schools.

I hope to make this journey an annual pilgrimage to the various Clontarf academies around Australia. Again taking with me mentor like figures from all walks of life, together with the financial support of Clontarf sponsors who made the trek possible.

All transportation, meals and accommodation (mostly camping in some of the most beautiful outback areas of NSW) were directly covered by the Clontarf Foundation.




