The curriculum is practical and applied, and challenges participants to prepare for their future roles through a combination of self-reflection, structured small group work and whole-of-cohort dialogues.</p> <p>APL is a non-partisan program bringing together MPs from the federal, state and territory parliaments. It is expected that participants will have had no or minimal ministerial experience and have reasonable prospects for a ministerial career.</p>
