Bills

95.01 Bill introduced and passed all stages

On 9 February, the Special Minister of State presented the Members of Parliament (Life Gold Pass) and Other Legislation Amendment Bill 2012 and presented an explanatory memorandum to the bill. The Minister then moved that the bill be read a second time and, by leave, debate ensued. Following the second reading of the bill, leave was granted for the third reading to be moved immediately. The Minister made some concluding remarks and the bill was read a third time.

On 7 February, the Prime Minister moved a motion of condolence in relation to the death of Sir Zelman Cowen AK, GCMG, GCVO, QC, a former Governor-General of Australia. The Leader of the Opposition seconded the motion and a number of Members spoke in support. Following debate on the motion, all Members present then rose in silence as a mark of respect. The condolence motion was then referred to the Main Committee for further debate.

The motion was returned to the House the following day, and agreed to as all Members again rose in their places.

During second reading debate on the Fairer Private Health Insurance Incentives Bill 2011 and related bills, the Leader of the House, by leave, moved to suspend standing orders to allow government business to take precedence until 11 pm that night. The motion provided that all divisions (other than on a motion moved by a Minister) or quorums be deferred until after a ministerial statement by the Prime Minister the following morning.

The question was agreed to and the second reading debate continued until the House adjourned at 11 pm.

95.11 Prime Minister's Ministerial Statement at 9 am – referral to Main Committee

Following the acknowledgement of country and Prayers, the Prime Minister, by leave, made a ministerial statement on 'closing the gap' between Indigenous and non-Indigenous Australians, and presented a document entitled *Closing the gap: Prime Minister's report 2012*. Standing orders were suspended to allow the Leader of the Opposition to speak for an equal period of time and the Leader of the

Opposition addressed the House. A Minister moved that the House take note of the document, and the debate was adjourned. The order of the day was then referred to the Main Committee for debate.

Note: Ministerial statements are usually made after question time.

95.12 Fewer than four Members on one side in multiple divisions

On four divisions called for on amendments moved during consideration in detail of the Building and Construction Industry Improvement Amendment (Transition to Fair Work) Bill 2011, only three non-aligned Members voted on the side of the 'Ayes'. On each occasion, the Speaker declared the question resolved in the negative.

Note: Where four or fewer Members are on one side of the House after the doors are locked for a division, the Chair may declare the decision of the House immediately, without completing the count. The names of those in the minority are recorded in the *Votes and Proceedings*.

95.13 *Three matters of public importance proposed for discussion*

The Speaker announced that a Government Member, an Opposition Member and a non-aligned Member had each proposed matters of public importance for discussion that day. The Speaker chose the matter proposed by the non-aligned Member which in his opinion was the most urgent and important.

More than the required eight Members rose in their places to support the matter of public importance and discussion ensued.

On 13 February, five bills were introduced to the House during private Members' business time. Four bills were presented by non-aligned Members and one by a private Government Member.

After an Opposition Member's question to the Prime Minister had been answered during question time, the Member asked a supplementary question. The Speaker ruled the supplementary question out of order as it did not sufficiently arise from the answer given by the Prime Minister.

95.17 Speaker's statement regarding procedural changes, divisions, disorderly behaviour and questions to Speaker

On the first sitting day of the year, the Speaker made a statement to the House regarding procedural matters. Firstly, the Speaker indicated that he had made proposals to shorten time limits during question time and to rename the Main Committee the Federation Chamber. Standing orders were amended the following day implementing these changes (see entry **95.24**).

The Speaker then advised Members that he would take the chair if requested during divisions as done by the previous Speaker. He noted that if required to

exercise the casting vote, he would follow the principles outlined in *House of Representatives Practice*—that the Speaker should always vote for further discussion; where no further discussion is possible, decisions should not be taken except by a majority; and a casting vote on an amendment should leave the bill in its existing form.

The Speaker also advised that it was not his intention to warn Members before directing them to leave the Chamber for one hour under standing order 94 (a). In addition, he said that he would not necessarily warn a Member before naming the Member.

Finally, he reminded Members that questions to the Speaker following question time were limited under standing order 103 to matters of administration for which the Speaker is responsible.

After question time on 7 February, the Speaker announced that he had received from the Governor-General the authority to administer the oath or affirmation of allegiance to Members.

95.19 Speaker's statement regarding supplementary questions

Prior to the adjournment debate on 7 February, the Speaker made a statement regarding supplementary questions during question time. He advised Members that it was his intention, for a trial period, to allow up to five supplementary questions each day, with the aim of making question time more spontaneous.

The Speaker explained that the Opposition would be allowed two supplementary questions (one by the Leader of the Opposition or his delegate and one by any Opposition Member), private Government Members would be allowed two supplementary questions and when a non-aligned Member asked a question, a supplementary question would be permitted. The Speaker noted that a supplementary question must not introduce new matter, should not contain any preamble and must arise out of, and refer to the answer given to the original question. The Speaker advised that supplementary questions would be limited to 20 seconds and answers to supplementary questions limited to one and a half minutes.

The Speaker added to this statement the following day clarifying that non-aligned Members would be allowed one supplementary question, in total, each week.

Standing orders

95.24 *Amendments to standing orders*

The Leader of the House, pursuant to notice, moved a number of amendments to the standing orders. The amendments provided for the shortening of questions and answers during question time limiting questions to 30 seconds (previously 45 seconds) and answers to 3 minutes (previously 4 minutes).

The amendments also provided for the renaming of the Main Committee to the Federation Chamber, effective from 27 February 2012. The motion by the Leader of the House included an amendment to a resolution of the House to reflect the renaming of the Main Committee. The motion also proposed a new resolution providing that from 27 February, all matters referred to the Main Committee shall be considered to have been referred to the Federation Chamber.

Following debate, the motion was agreed to on the voices.
