Bills

21.01 Government takes carriage of private Senators' bills

During government business time on 18 June the Treasury Laws Amendment (Axe the Tampon Tax) Bill 2018, a private Senator's bill, was transmitted from the Senate and read a first time. The Leader of the House moved that the second reading be made an order of the day for the next sitting. A non-aligned Member moved an amendment to allow the second reading to be debated immediately and began to address the House. The Leader of the House immediately moved that the question be now put, which was agreed to on division. The original question that the second reading be made an order of the day for the next sitting was accordingly put, and carried on the voices. [Watch]

During Government business time on 26 June, a message from the Senate was received transmitting the Taxation Administration Amendment (Corporate Tax Entity Information) Bill 2018, a private Senators' bill, for concurrence. The bill was read a first time and the Minister for Law Enforcement and Cyber Security moved that the second reading be made an order of the day for the next sitting. The Deputy Manager of Opposition Business began to move an amendment to the motion, however the Minister immediately moved that the question be now put, which was carried on division. The original motion was then accordingly put and carried on the voices. [Watch]

When a private Senator's bill is transmitted from the Senate, a private Member may move that the second reading be made an order of the day for the next sitting. The bill is then listed on the Notice Paper as an item of private Members' business. If a Minister moves the motion the bill is listed as government business, but does not necessarily indicate Government support for the further passage of the bill.

21.02 Consideration of Senate message relating to the Treasury Laws Amendment (Personal Income Tax Plan) Bill 2018

During government business time on 21 June, the Speaker reported a message from the Senate returning the Treasury Laws Amendment (Personal Income Tax Plan) Bill 2018 with amendments. The Treasurer moved that the amendments be considered immediately and the Manager of Opposition Business began to speak to the motion. The Treasurer immediately moved a motion to put the question which was carried on division. The question that the amendments be considered immediately was accordingly put and carried on division.

The Speaker stated that he understood that it was the wish of the House that the amendments be considered together, and the Treasurer subsequently moved that the amendments be disagreed to. That question was stated to the House by the Speaker. The Manager of Opposition Business raised a point of order, contesting that there was not agreement for the amendments to be considered together. The Speaker stated that as the question had been stated from the Chair it was now not possible to consider the amendments separately. The Treasurer moved a motion to put the question, which was carried on division. The question that the amendments be disagreed to was accordingly put and carried on division. The Treasurer presented the reasons for the House disagreeing to the Senate amendments and moved that the reasons be adopted. The Manager of Opposition Business began to move an amendment to the motion and the Treasurer moved that the question be put which was carried on division. The question that the reasons be adopted was then put and carried on division. [Watch]

The motion 'That the question be now put' can only be moved once the terms of the motion have been proposed from the Chair, but can be moved while another Member is speaking to the motion or even in the process of moving an amendment.

21.03 Appropriation Bills returned to the House and agreed to

On 21 June during government business time, the Deputy Speaker reported to the House that the Appropriation Bill (No. 1) 2018-2019, Appropriation Bill (No. 2) 2018-2019, Appropriation (Parliamentary Departments) Bill (No. 1) 2018-2019, Appropriation Bill (No. 5) 2018-2019, Appropriation Bill (No. 6) 2018-2019 had been fully considered by the Federation Chamber and returned without amendment. Consecutive motions for the third reading of each bill were then agreed to without further debate.

Debate

21.07 Members decline to withdraw remarks

During the discussion on the matter of public importance on 21 June, an Opposition Member used the following words "Malcolm Turnbull, the Prime Minister of Australia, used the phrase 'university educated' as an insult this week. You know who else uses that sort of language as an insult? You know who else went after the intelligentsia? Pol Pot. General Franco. That's what happens when that sort of language is used..." A Government Member requested that the Member withdraw. The Chair then asked the Member to withdraw and the Member refused, stating that the Speaker had not ruled her to withdraw. The Chair allowed the Member to continue her speech. [Watch]

Later, during the same discussion, a Government Member used the following words "The member for Griffith, in her Academy Award winning speech—...likened the Prime Minister to...Pol Pot". An Opposition Member requested that the Member withdraw. The Chair asked the Member to withdraw and the Member refused, stating that the Speaker had not ruled him to withdraw. The Chair allowed the Member to continue his speech. [Watch]

21.08 Member given call after duty Minister sums up debate

After the duty Minister summed up the second reading debate on the Treasury Laws Amendment (2018 Measures No. 4) Bill 2018 on 25 June, a Government Member rose to speak on the bill. The Deputy Speaker advised the House that as the duty Minister did not move the motion the debate had not concluded and the Member was entitled to be given the call to speak. At the conclusion of the Member's speech, the question on the second reading was then put and passed on the voices. The duty Minister then, by leave, moved that the bill be read a third time which was carried on the voices.

Only the mover of a motion closes the debate when they speak again in reply. The speech of a Minister acting on behalf of the mover of the original motion does not close the debate.

21.09 Minister granted extension of time to continue second reading speech

During the second reading debate on the National Security Legislation Amendment (Espionage and Foreign Interference) Bill 2018 on 26 June, the Attorney-General's time expired while he was closing the debate. The Attorney-General moved that time for his speech be extended, which was carried on the voices.

A Member may be granted an extension of time for one period up to 10 minutes, but no extension may exceed half of the original period allotted.
