During his answer to a question without notice, the Treasurer referred to specific criminal charges that had been made in connection with the construction industry. Following a point of order, the Speaker cautioned the Treasurer to be careful about transgressing the sub judice conventions of the House. [\[Watch\]](#)

*The sub judice convention provides that, subject to the right of the House to legislate on any matter, matters awaiting adjudication in a court of law should not be brought forward in debate, motions or questions. This self-imposed restriction prevents the deliberations of the House and reports of its proceedings from prejudicing the course of justice.*
