#### Bills

#### 27.01 Supply bills introduced and passed by the House

On 2 April 2019, prior to the presentation of the Budget, three supply bills were introduced, each preceded by a message from the Governor-General recommending appropriation: Supply Bill (No. 1) 2019-2020, Supply Bill (No. 2) 2019-2020, and Supply (Parliamentary Departments) Bill (No. 1) 2019-2020. Following the introduction of each bill, the debate was adjourned and the resumption of the debate, by leave, was made an order of the day for a later hour. After a short cognate debate, the questions on each bill were put and was carried on the voices.

The bills provide for five-twelfths of the 2019-2020 appropriations, that is, for the first five months of the financial year.

Supply bills ensure continuity of normal government business in the event that the House of Representatives is dissolved before the Budget bills have passed.

### 27.02 Presentation of 2019-2020 Budget

On Tuesday 2 April, following a suspension of sitting from 7.02pm to 7.30pm, the Speaker reported a message from the Governor-General recommending an appropriation for the purposes of Appropriation Bill (No.1) 2019-2020. The Treasurer then presented the bill, moved the second reading and delivered the budget speech. Debate was adjourned and the Special Minister of State presented budget-related documents. [Watch]

The Special Minister of State then presented Appropriation Bill (No. 2) 2019-2020 and Appropriation (Parliamentary Departments) Bill (No. 1) 2019-2020. Before each of the bills was introduced, the Speaker announced receipt of a message from the Governor-General recommending appropriation.

Government business continued until 8.53pm, when the House adjourned without debate.

The Deputy Chair, by leave, presented a copy of his statement.

As the committee responsible for parliamentary oversight of the ANAO and PBO, the Joint Committee of Public Accounts and Audit is required by legislation to consider the draft budget estimates for each office. On Budget day each year the Committee makes a statement on whether, in its opinion, these offices have been given sufficient funding to carry out their respective mandates.

## 27.09 Resolution regarding Members' qualifications

On 4 April, the Special Minister of State moved a motion requiring all Members in the next Parliament to provide statements in relation to their eligibility under sections 44 and 45 of the Constitution. The motion provided that the Registrar of Members' Interests maintain a public Register of Members' qualifications and set out procedures for the House to deal with questions of qualification and referral of matters to the Court of Disputed Returns.

The Minister advised that the motion replaced a similar resolution adopted by the House in December 2017. He explained that the motion had been developed in response to the Joint Standing Committee on Electoral Matters report, *Excluded: the impact of section 44 on* 

Australian democracy. The motion was carried on the voices. (The Senate agreed to a similar motion in respect of Senators the previous day

# 27.13 Senate resolution on Murray-Darling Basin; Speaker gives casting vote

A message was reported informing the House that the Senate had agreed to a resolution concerning the Murray-Darling Basin, calling on the Government to support the repeal of the limit on Commonwealth water purchases. The Senate requested the concurrence of the House in the resolution.

The Minister for Agriculture and Water Resources moved that the House disagree with the resolution. The Manager of Opposition Business moved, as an amendment, that the House agree with the resolution. Following debate, the amendment was negatived on division. The House then divided on the question that the House disagree with the Senate resolution.

The numbers for the 'Ayes' and the 'Noes' being equal, the Speaker gave his casting vote with the 'Noes' in accordance with the principle that where no further discussion is possible, decisions should not be taken except by a majority.
