Bills

6.01 Treasury Laws Amendment (2019-20 Bushfire Tax Assistance) Bill 2020 introduced and passed by the House

During government business on 5 February, the Treasurer introduced the Treasury Laws Amendment (2019-20 Bushfire Tax Assistance) Bill 2020, together with an explanatory memorandum. The Treasurer moved that the bill be read a second time and made his second reading speech. Debate, by leave, continued and a number of Members spoke. Upon conclusion of debate, the bill was read a second time. A minister, by leave, moved that the bill be read a third time and the question was agreed to on the voices. The bill was passed by the House.

6.02 Appropriation Bill (No. 3) 2019-2020 and Appropriation Bill (No. 4) 2019-2020 introduced

On 13 February, a minister presented Appropriation Bill (No. 3) 2019-2020 and Appropriation Bill (No. 4) 2019-2020 and made a second reading speech for each bill. Debate on each bill was adjourned to a future sitting.

The Speaker announced receipt of a message from the Governor-General recommending an appropriation for the purposes of each bill before each was presented.

6.03 Condolence motion on Australian bushfires

Following prayers and acknowledgement of country on 4 February, the Leader of the House moved that standing orders be suspended to allow for the Prime Minister to move a motion of condolence in relation to the recent Australian bushfires and for debate on the motion to have precedence over all other business. The motion also provided that the Federation Chamber would not meet that day. The question was carried.

The Prime Minister then moved a motion of condolence acknowledging the devastation caused by the bushfires during the summer and extending the sympathies of the House to the families who had lost loved ones and to those who had suffered injuries or loss. The motion was seconded by the Leader of the Opposition and debate continued for the rest of the day. At the conclusion of debate, all Members present rose in silence as a mark of respect to the memory of the deceased. Debate was adjourned and the order of the day was referred to the Federation Chamber for further debate.

At 7.53 pm, the House adjourned as a mark of respect to the victims of the Australian bushfires. [Watch]

On 5, 6, 11 and 12 February, the condolence motion was further debated in the Federation Chamber

On 12 February, the condolence motion was returned to the House and, all Members present having risen in silence, the motion was carried.

At the conclusion of a condolence motion, the Speaker puts the question and asks Members to signify their approval of the motion by rising in their places for a short period of silence.

6.04 Suspension of standing orders to change order of business in the Federation Chamber

On 4 and 5 February, an assistant minister moved to suspend standing orders to allow for a variation to the order of business in the Federation Chamber for the following day. The motions allowed for the Australian bushfires condolence motion to be the only item of business in the Federation Chamber on 5 and 6 February. The suspension motions were agreed to on the voices.

6.05 Arrangements for visit by the President of the Republic of Indonesia

On 5 February, the Leader of the House, pursuant to notice, moved a motion inviting His Excellency Mr Joko Widodo, President of the Republic of Indonesia, to attend and address the House on Monday, 10 February 2020. The motion provided for welcoming remarks by the Prime Minister and the Leader of the Opposition to take place at 11.30 am, prior to the address by His Excellency. The motion also provided for a message to be sent to the Senate inviting Senators to attend the House as guests for the address. The motion was carried on the voices.

6.06 New Deputy Leader of National Party of Australia and New Leader of Australian Greens announced

Prior to question time on 5 February, the Deputy Prime Minister informed the House that the Member for Maranoa (Mr Littleproud) had been elected as the Deputy Leader of the National Party of Australia.

Later, the Member for Melbourne (Mr Bandt) informed the House that he had been elected Leader of the Australian Greens.

6.07 Address by the President of the Republic of Indonesia

On 10 February, following the acknowledgement of country and reading of prayers, the Speaker welcomed the President of the Senate and Senators, who had assembled in the House of Representatives Chamber, as guests. The President of the Republic of Indonesia, His Excellency Mr Joko Widodo was announced and the Speaker welcomed President Widodo. The Prime Minister and the Leader of the Opposition each made welcoming remarks and the Speaker invited President Widodo to address the meeting. President Widodo addressed the House in Bahasa Indonesia, the official language of Indonesia. The Speaker, on behalf of the House, expressed thanks to the President, who then departed the Chamber. The sitting was then suspended from 12.15 pm to 2.30 pm. [Watch]

6.08 Consideration of Senate message relating to private Senator's bill

On 11 February, the Speaker reported a message from the Senate informing the House that the Senate had agreed to a resolution calling on the government to bring on the Australian Greens' National Integrity Commission Bill 2018 (No. 2), in the House of Representatives, for a vote during the February 2020 sittings, and requesting the concurrence of the House with the resolution. The Deputy Leader of the House moved that consideration of the Senate message be made an order of the day for the next sitting.

The Leader of the Australian Greens (Mr Bandt) moved, as an amendment, that the message be considered immediately. Before the amendment could be seconded, the Deputy Leader of the House moved that the question be put. The closure motion was agreed to on division. The question that the Senate message be made an order of the day for the next sitting was subsequently agreed to on division.

The Closing the Gap report is an annual report to parliament on progress in closing the gap between outcomes for Indigenous and non-Indigenous Australians.

6.13 Opposition motion to suspend standing orders – Minister for Health

Privilege

6.15 Matter of Privilege – Statement by Speaker

On 5 December 2019, the Manager of Opposition Business raised a matter of privilege regarding whether statements made to the House by the Minister for Energy and Emissions Reduction had misled the House, constituting contempt of the House (see entry **5.28**).

The Speaker responded on 5 February. He explained that in order to establish that contempt had been committed in this case, it would need to be shown that a statement had been misleading, the member knew at the time the statement was incorrect and the misleading had been deliberate. In the Speaker's view, a *prima facie* case for contempt had not been made out. As such, in accordance with the practice of the House, the Speaker did not give precedence to a motion to refer the matter to the Committee of Privileges and Members' Interests.

The Speaker noted that the Prime Minister had been allowed a preamble and asked that he address the specific part of the question.

6.19 Resignation of Deputy Speaker

The Speaker thanked the Deputy Speaker for his service and informed the House that a ballot to elect a new Deputy Speaker would take place on Monday, 10 February following question time.

6.20 Question to the Speaker – Parliament House cybersecurity

Following question time on 6 February, the Member for Gellibrand (Mr Watts) asked the Speaker to comment on a podcast episode in which a former minister and a former departmental secretary discussed a cybersecurity incident at Parliament House discovered in January 2019. The Speaker noted that, at the time, both he and the President of the Senate had balanced the need for transparency with national security concerns in making statements to the parliament. However, he stressed that any inference that those statements were inaccurate or misleading as to the seriousness of the situation were false.

6.21 Election of Deputy Speaker

On 10 February, the Speaker informed the House that the Member for Page (Mr Hogan) had tendered his resignation as Deputy Speaker of the House of Representatives. He then called for nominations for a new Deputy Speaker.

A Government Member, Dr Webster, nominated the Member for Nicholls (Mr Damian Drum). The Manager of Opposition Business nominated the Member for Wide Bay (Mr Llew O'Brien) and the Deputy Manager of Opposition Business seconded the nomination. Both nominees are members of the government.

Members then proceeded to vote by ballot. Mr O'Brien received 75 votes and Mr Drum received 67. The Speaker thereby declared Mr O'Brien elected Deputy Speaker. The Prime Minister, the Leader of the Opposition, the Leader of the Nationals and the Speaker each made congratulatory remarks.

In accordance with standing order 13, if a government Member is elected as Deputy Speaker, only a non-government Member may be elected Second Deputy Speaker. If a non-government Member is elected as Deputy Speaker, only a government Member may be elected as Second Deputy Speaker.
