## Bills

### 11.01 Consideration of Senate amendments to Treasury Laws Amendment (2019 Measures No. 3) Bill 2019

During government business time on 15 June, the Speaker reported a message from the Senate returning the Treasury Laws Amendment (2019 Measures No. 3) Bill 2019 with amendments. An Assistant Minister moved that the amendments be disagreed to. Following debate the question was put and carried on division. The Assistant Minister subsequently presented the reasons of the House for disagreeing to the amendments of the Senate, and these were adopted by the House.

On 16 June, the Speaker reported a message from the Senate informing the House that the Senate insisted on the amendments disagreed to on 15 June. An Assistant Minister moved that the House insist on disagreeing to the amendments insisted on by the Senate. Following debate, the House divided and subsequently agreed to the motion moved by the Assistant Minister.

On 17 June, the Speaker reported a message from the Senate returning the Treasury Laws Amendment (2019 Measures No. 3) Bill 2019 and informing the House that the Senate did not again insist on its amendments disagreed to by the House of Representatives.

### 11.02 Consideration of Senate amendments to Crimes Legislation Amendment (Sexual Crimes against Children and Community Protection Measures) Bill 2019

As the first item of business on 16 June, the Speaker reported a message from the Senate returning the Crimes Legislation Amendment (Sexual Crimes against Children and Community Protection Measures) Bill 2019 with amendments. Amendments (1) and (3) were agreed to after debate and amendment (2) was disagreed to.

The Leader of the House subsequently presented the reasons of the House for disagreeing to the amendment of the Senate, and these were adopted by the House.

### 11.03 Senate resolution relating to the National Integrity Commission Bill 2018 (No. 2)

On 16 June, the Speaker reported a message from the Senate, communicating that the Senate had agreed to a resolution calling on the Government to bring on the National Integrity Commission Bill 2018 (No. 2) (a private Senator's bill) in the House for a vote in the June 2020 sittings and requesting the concurrence of the House. The Leader of the House moved that the message be considered at the next sitting. The Leader of the Australian Greens moved, as an amendment, that the message be considered immediately. Before the amendment could be seconded, the Leader of the House moved that the question be put, which was agreed to on division. The question that the Senate message be considered at the next sitting was accordingly put and carried on division.

### 11.04 Consideration of Senate amendments to Treasury Laws Amendment (2020 Measures No. 2) Bill 2020

## Business

### 11.05 Special arrangements for sitting – COVID-19

Similar to the previous sittings, due the COVID-19 pandemic, special arrangements were adopted in the Chamber to ensure Members were able to participate in proceedings while still complying with social distancing requirements. At least 80 Members were paired for each division in the first week and 40 Members in the second week. Arrangements also included rotating seating plans to provide all Members who attended the sittings with a seat

in the Chamber for at least a couple of days of the sitting fortnight. Two lecterns were put in place at the rear of the Chamber, allowing Members with seats outside the normal horseshoe seating or no seat at all to speak.

### 11.06 Suspension of standing orders – Order of business for 10, 11 and 12 June

In a typical sitting week, the House sits from Monday to Thursday. However, in the first week of the sitting fortnight, the House sat on Wednesday, Thursday and Friday. On Wednesday morning, the Leader of the House moved to suspend standing orders to set the order of business for each day. The motion provided for committee and delegation business and private Members' business, as determined by the Selection Committee, to be considered on Wednesday morning (private Members' business usually occurs on Monday mornings).

The motion also provided that for Thursday, 11 June the standing orders would apply to the necessary extent as if it was a Wednesday and for Friday, 12 June the standing orders would apply as if it was a Thursday. The motion was debated and carried, in accordance with standing order 47(c)(ii).

### 11.07 Statements on indulgence – William Callaghan

Special thanks were given to Ben Gibbs, an experienced bushman, who found William. The Minister for Health also thanked the searchers, emergency workers, police and everybody involved in the search.

### 11.08 Motion to rearrange government business

On 16 June, an Assistant Minister moved to postpone two items of government business, including a notice of motion to bring on a disallowance motion sponsored by the Leader of the Opposition, to a later hour. The Manager of Opposition Business moved, as an amendment, that the items of business be postponed until 7.00 pm that day. The Speaker ruled the amendment out of order and explained that a private Member cannot move an amendment to a postponement motion which would have the effect of varying the order of government business. The Assistant Minister then moved that the question be put, which was agreed to on division. The postponement of business motion was also agreed to on division.

### 11.09 Senate resolution relating to COVID-19 recovery package for the arts and entertainment industry

On 18 June, the Deputy Speaker reported a message from the Senate, communicating that the Senate had agreed to a resolution calling on the Government to detail and deliver a recovery package for the arts and entertainment industry, which has been affected by COVID-19. The Senate requested the agreement of the House with this resolution. The Minister for Population, Cities and Urban Infrastructure moved that the message be considered at the next sitting. The Leader of the Australian Greens moved, as an amendment, that the message be considered immediately. He was then closed on division. An independent Member seconded the amendment and was also closed on division. Before the amendment was proposed by the Chair, the Leader of the House moved that the question be put, which was agreed to on division. The amendment was therefore superseded and the question that the Senate message be considered at a later sitting was accordingly put and carried on division.

The suspension motion was subsequently disagreed to on division.

### 11.18 Motion to suspend standing orders – Live animal exports

On 16 June, the Member for Clark (Mr Wilkie) moved to suspend standing orders to allow him to move a motion which, among other things, called on the Government to immediately prevent the Al Kuwait from departing Australia with its cargo of live sheep, develop a plan to shut down the live animal export industry, and establish an Independent Office of Animal Welfare. The mover and seconder were closed on division. The question that the suspension motion be disagreed to was carried, with fewer than five members voting on the side of the noes.

In response, the Minister argued that those remarks by the Manager of Opposition Business were inaccurate and should be withdrawn.

The Speaker reminded the House that the Chair does not have the capacity to judge the accuracy of questions and answers. He also reminded the House that personal explanations could be made at the end of question time and provided an opportunity to correct the record.

Prior to the matter of public importance, the Manager of Opposition Business made a personal explanation, stating that his remarks had been accurate in relation to the Opposition's support for the passage of the legislation.

### 11.23 Question to the Speaker and personal explanation – Persons referred to in the House

Following question time on 17 June, the Shadow Minister for Health asked the Speaker a question regarding the citizen's right of reply. The shadow minister noted that, in accordance with a resolution of the House adopted on 27 August 1997, persons offended by remarks made about them in the House, under certain circumstances, may ask for a response to be published in *Hansard*.

The shadow minister asked the Speaker if the citizen's right of reply extended to organisations. Specifically, he asked if the Speaker would accept a submission for a right of reply from pharmaceutical company Eli Lilly or Migraine Australia in response to remarks made about those organisations by the Minister for Health earlier in the day. The Speaker said that he would report back to the House.

The Minister for Health then made a brief personal explanation in response.
