## Bills

### 14.01 Opposition motion for passage of the Economic Recovery Package (JobMaker Hiring Credit) Amendment Bill 2020

At 3.13pm on 19 October, the Manager of Opposition Business moved to suspend standing orders to allow for the government's Economic Recovery Package (JobMaker Hiring Credit) Amendment Bill 2020 to be called on immediately and given priority over other business for passage through all stages that day. The question was carried on the voices.

The bill was then called on and, following debate, passed all stages.

### 14.02 Consideration of the Budget

On Tuesday, 20 October, debate resumed on the second reading of Appropriation Bill (No. 1) 2020-2021, cognate with Appropriation Bill (No. 2) 2020-2021 and Appropriation (Parliamentary Departments) Bill (No. 1) 2020-2021 (also known as the budget debate). The Shadow Assistant Treasurer was the first speaker and moved an amendment critical of certain aspects of the budget.

Later in the day, the Chief Government Whip referred the bills to the Federation Chamber for further consideration.

The debate continued in the Federation Chamber throughout the fortnight. In both sitting weeks, standing orders were suspended to alter the Federation Chamber's order of business to allow additional time for the debate.

On Wednesday, 28 October, the second reading amendment was negated and the question that the bill be read a second time was carried. In total, 81 members spoke in the budget debate. Consideration in detail of the bill was made an order of the day for a later sitting.

## 14.03 Recycling and waste reduction bills package—rescission of resolutions

Following consideration in detail of the Recycling and Waste Reduction Bill 2020 on 26 October, the Assistant Minister for Waste Reduction and Environmental Management sought and was denied leave to move the third reading immediately. He then, pursuant to contingent notice, moved to suspend standing orders to allow the third reading to be moved without delay.

During the debate, the Manager of Opposition Business indicated that the opposition would not cooperate to expedite the passage of the bills package, as a means to ‘push back’ against the practice of debates being closed in the House.

The debate on the suspension motion was closed and the motion was carried on division. The question that the bill be read a third time was then put and carried, without the motion having been moved by a minister.

The House then passed four related bills. In each case, the bill was read a second time and leave was denied to move the third reading immediately. Standing orders were then suspended to allow the third reading to be moved. The question that the bill be read a third time was put and carried, without the motion having been moved by a minister.

On 28 October, a minister successfully moved that the resolutions of the House agreeing to the third readings of the five bills be rescinded and that each bill be called on and the third reading moved by a minister for resolution without debate. Each of the bills was then called on successively and the third reading of each was moved and carried on the voices.

### 14.04 Ministerial statements

On Tuesday, 27 October, the Minister for Industry, Science and Technology made a ministerial statement relating to Australian industry and manufacturing and the shadow minister made a statement in reply.

The following day, the Minister for Resources, Water and Northern Australia made a ministerial statement on developing Northern Australia. A shadow minister spoke in reply.

On 29 October, the Minister for Energy and Emissions Reduction also made a ministerial statement, relating to Australia’s energy future. The Manager of Opposition Business then, on a point of order, suggested that the content of the statement had been contrary to practice and asked the Speaker to advise the House on the expectations for ministerial statements.

The Speaker responded that the purpose of ministerial statements was to announce government policy or matters for which the minister concerned was responsible and there was no flexibility to speak about anything else, including political matters.

The shadow minister then made his statement in reply.
