Bills

21.01 Budget debate

Debate resumed on the second reading of the main appropriation bill on 24 May, in cognate with Appropriation Bill (No. 2) and Appropriation (Parliamentary Departments) Bill (No. 1). The Shadow Treasurer spoke first and moved a second reading amendment to the bill. Later in the day, the Leader of the Australian Greens moved an amendment to the amendment proposed by the Shadow Treasurer. The three bills were referred to the Federation Chamber, by programming declaration, at the adjournment of the debate.

The budget debate continued in the Federation Chamber throughout the sitting fortnight. On Thursday, 3 June, the question was put on the amendment moved by the Leader of the Australian Greens and, as it could not be decided on the voices, the main appropriation bill was returned to the House with an unresolved question. There, the amendment was negatived on division and the amendment moved by the Shadow Treasurer was negatived on the voices. The bill was read a second time and was referred back to the Federation Chamber for the consideration in detail stage.

Later in the day, the House agreed to suspend standing orders to alter the order of business in the Federation Chamber, from 15 to 17 June, to allow more time for consideration of the appropriation bills.

21.02 Customs Tariff Proposal

On 26 May, the Assistant Minister for Customs, Community Safety and Multicultural Affairs moved Customs Tariff Proposal (No. 3) 2021. He explained that the proposal provided a tariff concession for prescribed goods for use in the manufacture and development of motor vehicles designed or engineered in Australia.

By convention, duties can be collected from the day a tariff proposal is moved, even though the motion has not been agreed.

21.03 Adjournment negatived to allow passage of bill

On 3 June, debate resumed on the second reading of the Treasury Laws Amendment (Your Future, Your Super) Bill 2021. The bill was read a second time and a message from the Governor-General recommending appropriation was announced before the time for the automatic adjournment. At 4.30pm the question that the House do not adjourn was proposed. The Assistant Treasurer required the question to be put immediately without debate and the question was carried on division.

The House proceeded to consider the bill in detail. Amendments proposed by the government, opposition and independent members were decided and the bill, as amended, was agreed. The Assistant Treasurer moved that the bill be read a third time and the question was carried on division. The House was then adjourned, without debate, at 5.14pm.

The House usually adjourns at 5pm on Thursdays, following a thirty minute adjournment debate.

21.07 Same motion disallowed

On 26 May, an opposition member moved to suspend standing orders to allow her to move a motion calling for the Chair of the Standing Committee on Employment, Education and Training to be discharged from the committee, in light of recent allegations made against him. The Speaker noted that the motion was almost identical to a motion negatived the previous day and similar in substance to a number of other motions recently moved by opposition members. He explained that the same motion could not be continuously moved once the House had determined the matter and ruled that he could not accept the motion.

The Speaker may disallow any motion or amendment which he or she considers is the same in substance as any question already resolved in the same session (SO 114 (b)).

21.08 Agreement for members to contribute remotely

On 27 May, following the announcement of COVID-19 restrictions in Victoria, the Leader of the House presented an *Agreement for members to contribute remotely to parliamentary proceedings* to apply for the following week. As with similar agreements made between the Leader of the House and Manager of Opposition Business this parliament, the agreement

allowed for members unable to attend sittings because of the pandemic to participate in certain proceedings remotely via the official video facility.

Privilege

21.10 Statement by Speaker on privilege matter

On 24 May the Speaker made a statement in response to a matter of privilege raised by an independent member (Mr Craig Kelly) the previous sitting week (see **20.15**). The matter concerned whether the member's banning by Facebook on its social media platforms represented an improper interference with the free performance of his duties as a member such as would amount to a contempt of the House.

The Speaker noted Facebook's explanation that it had removed the member's Facebook page because he had violated its policy of not allowing users to share misinformation about COVID-19. He also acknowledged the member's concern that the action had impeded his ability to communicate with his constituents. However, he did not find, on the information provided, that a prima facie case of improper interference had been made out. Accordingly, he did not give precedence to a motion to refer the matter to the Committee of Privileges and Members' Interests.
