## Bills

### 27.01 Coronavirus response bills introduced and pass all stages in one day

On 9 February, the Assistant Treasurer presented Appropriation (Coronavirus Response) Bills Nos. 1 and 2. Before the presentation of each bill, a message from the Governor-General was announced recommending appropriation for the purposes of the bill. In his second reading speeches, the Assistant Treasurer explained that the bills were time sensitive as they provided additional appropriation for coronavirus response programs through February and March. At the conclusion of the minister's speech on each bill, leave was granted for the debate to resume later in the day.

Debate later resumed on Appropriation (Coronavirus Response) Bill (No. 1) 2021-2022, in cognate with the second bill. The Shadow Treasurer was the first speaker and moved a second reading amendment. At the conclusion of the debate, the amendment was negated on the voices and both bills, in turn, passed all remaining stages on the voices.

### 27.02 Extended sitting for passage of religious discrimination bills; Speaker gives casting vote; government loses votes on the floor of the House

On 9 February, debate resumed on the second reading of the Religious Discrimination Bill 2021, in cognate with the Religious Discrimination (Consequential Amendments) Bill 2021 and the Human Rights Legislation Amendment Bill 2021. Just before the time for the adjournment of the House to be proposed, standing orders were suspended to allow for an extended sitting for consideration of the three bills, as well as three unrelated bills. The second reading cognate debate on the Religious Discrimination Bill 2021 then continued until after 1am.

At the conclusion of the debate, a second reading amendment was negated on division and the question that the bill be read a second time was carried on division. The bill then

proceeded to the consideration in detail stage. Amendments moved by the Leader of the Australian Greens and by the Member for Hughes were disagreed to.

Government amendments were then moved and carried on the voices. A minister moved another set of government amendments and the Shadow Attorney-General moved an amendment to one of these amendments. The question that the opposition amendment to the government amendment be disagreed to was put and a division called. The numbers for the ayes and the noes being equal, the Speaker gave his casting vote with the ayes on the principle that, where further discussion is not possible, decisions should not be taken except by a majority. The government amendments were then carried.

Opposition amendments were then moved and disagreed to on division. Consideration in detail concluded and the question that the bill be read a third time was carried on division.

The Religious Discrimination (Consequential Amendments) Bill 2021 was then called on, read a second time and passed by the House.

Next, the Human Rights Legislation Amendment Bill 2021 was called on and read a second time before proceeding to the consideration in detail stage. The Centre Alliance member, Ms Rebekha Sharkie, moved an amendment which was negated on division. She then moved another amendment. The House divided on the question that the amendment be disagreed to. The question was negated, with five government members 'crossing the floor' to vote in support of the amendment. The question that the amendment be agreed to was then put and carried on division. The question that the bill, as amended, be agreed to was put and carried, with most government members voting against. Consideration in detail concluded and the bill was read a third time.

Two other bills listed in the suspension motion were then passed by the House and consideration of a third bill was postponed. The House finally adjourned at 5.01am.
