## Bills

### 28.01 Supply bills introduced and pass all stages

Before the presentation of the Budget on Tuesday, 29 March, three supply bills were introduced, each preceded by a message from the Governor-General recommending appropriation: Supply Bill (No. 1) 2022-2023, Supply Bill (No. 2) 2022-2023 and Supply (Parliamentary Departments) Bill (No. 1) 2022-2023. After the introduction of each bill, debate was adjourned and the resumption of the debate, by leave, was made an order of the day for a later hour. Debate then resumed on the bills in cognate and one opposition member spoke. Later in the day, each of the supply bills was called on and passed all stages on the voices.

These bills provide for five-twelfths of the 2022-2023 appropriations—that is, they provide appropriation for the first five months of the financial year. They ensure continuity of normal government business in the event that the House of Representatives is dissolved before the Budget bills have passed.

### 28.02 Presentation of 2022-2023 Budget

On the afternoon of 29 March, the House agreed to suspend standing orders relating to the automatic adjournment of the House and the limit on new business after the normal time of adjournment to allow for the presentation of the budget (and for the budget reply).

Following a suspension of sitting from 5.59pm to 7.30pm, the Speaker reported a message from the Governor-General recommending an appropriation for the purposes of Appropriation Bill (No. 1) 2022-2023. The Treasurer then presented the bill, moved the second reading and delivered the budget speech. Debate was adjourned and the Assistant Treasurer presented budget-related documents. [\[Watch\]](#)

The Assistant Treasurer then presented Appropriation Bill (No. 2) 2022-2023 and Appropriation (Parliamentary Departments) Bill (No. 1) 2022-2023. Before each of the bills was introduced, the Speaker announced receipt of a message from the Governor-General recommending appropriation.

The House then adjourned at 8.16pm.

### 28.03 Cost of living bills introduced and pass all stages; rescission of resolution

On Wednesday, 30 March, the Assistant Treasurer presented the Treasury Laws Amendment (Cost of Living Support and Other Measures) Bill 2022. After the second reading speech, debate on the bill was adjourned to the next sitting. The Assistant Treasurer then presented the Excise Tariff Amendment (Cost of Living Support) Bill 2022 and the Customs Tariff Amendment (Cost of Living Support) Bill 2022. In both cases, following the second reading speech, leave was granted for the debate to be adjourned to a later hour that day.

Later, a minister moved that standing orders be suspended to allow the resolution fixing the resumption of debate on the Treasury Laws Amendment (Cost of Living Support and Other Measures) Bill 2022 for the next sitting to be rescinded and for the debate to instead be adjourned to a later hour that day. Each of the three bills was then called on and, in turn, passed all stages on the voices.

### 28.04 Senate road vehicle standard bill introduced and passes all stages

On Thursday 31 March, the Road Vehicle Standards (Consequential and Transitional Provisions) Amendment Bill 2022 was received from the Senate and read a first time. The Deputy Prime Minister moved the second reading and made the second reading speech. Leave was then granted for the second reading debate to continue immediately. After the shadow minister contributed to the debate, the Deputy Prime Minister was granted leave to move the third reading of the bill. The bill was then read a third time.

A number of members used the opportunity to present (by leave) and speak to committee reports. The House then suspended, at 5pm, to allow preparations to be made for an address by the President of Ukraine.

In accordance with a resolution of the House agreed the previous day, the President of Ukraine made an address to members and senators in the House of Representatives, by video facility, on 31 March.

Following a suspension of sitting from 5pm to 5.30pm, the Speaker, the Prime Minister and the Leader of the Opposition made welcoming remarks. President Zelenskyy then addressed the meeting, speaking about the Russian invasion of Ukraine. At the conclusion of President Zelenskyy's speech, the Speaker thanked him on behalf of the House. On Budget day each year the committee makes a statement on whether, in its opinion, these offices have been given sufficient funding to carry out their respective mandates.*
