## Bills

### 2.01 Resumption of debate on the Repeal Net Zero Bill 2025

During private members' business on 25 August, in accordance with the resolution agreed to on 31 July (see Digest 1.14), debate resumed on the second reading of the Repeal Net Zero Bill 2025. When the time allotted for debate expired, the debate was interrupted, and the resumption of the debate made an order of the day for the next sitting.

On 1 September, in accordance with the determinations of the Selection Committee, debate resumed on the second reading of the bill. An opposition member, by leave, spoke again, having already spoken when he seconded the motion at a previous sitting. When the time allotted for the debate expired, the debate was interrupted, and the resumption of the debate made an order of the day for the next sitting.

### 2.02 Request for amendments from the Senate

On 4 September, the Aged Care and Other Legislation Amendment Bill 2025 was returned from the Senate with requested amendments, following Committee of the Whole debate. The amendments related to funding for home care packages and would increase government expenditure, therefore requiring appropriation. A message from the Administrator recommending appropriation for the requested amendments had been reported to the House earlier. After debate, the requested amendments were made, and the bill was returned to the Senate.

Later that day, following the third reading in the Senate, the bill was returned and the House considered the amendments the Senate had been able to make as they did not require appropriation. These were agreed to by the House.

*Under Section 53 of the Constitution, the Senate cannot amend proposed legislation which imposes taxation, appropriates money for the ordinary annual services of the government or increases any proposed charge or burden on the people. The Senate must instead request that the House makes these amendments, and generally does so during its committee (detail) stage of bill consideration.*

## 2.03 Closure of debate during consideration in detail

On 3 September, the second reading was agreed to for the Defence Amendment (Defence Honours and Awards Appeals Tribunal) Bill 2025. That evening, consideration in detail commenced. A shadow minister moved, by leave, five amendments together and debate ensued. At 6.22 pm, a minister moved closure of question, which was carried on division. At 6.28 pm the House divided on the question that the opposition amendments be agreed to, which was negated. The question that the bill be agreed to was then put and carried on the voices, and, by leave, the bill was read a third time.

*Standing order 133 provides that on Mondays, Tuesdays and Wednesdays, any division called for from 6.30 pm until the adjournment of the House shall be deferred until the first opportunity the next sitting day, except for a division called on a motion to suspend any standing or other order of the House moved by a minister during this period or any division necessary to resolve the question on such a motion.*

## Standing and sessional orders

### 2.04 Amendment to standing order 215

On 26 August, the House resolved to suspend standing and sessional orders to enable the Leader of the House to move a motion to amend standing orders. The Leader of the House then moved the motion to amend standing order 215(d), which revised the committee membership for the Standing Committee on Climate Change, Energy, Environment and Water, and the Standing Committee on Health, Aged Care and Disability. The question was put and carried on the voices.

The amendment increased the number of crossbench members for the two committees from one to two, and reduced the number of opposition members from three to two.

The next day, crossbench members were appointed to the two committees in accordance with the amendment (see Digest 2.14).

### 2.05 Disallowance motion

During government business time on 26 August, the House resolved to suspend standing orders to call on the Member for Kooyong's notice of motion relating to the disallowance of item 12 of the Financial Framework (Supplementary Powers) Amendment (Health and Aged Care Measures No. 4) Regulations 2024. The Member for Kooyong then moved the disallowance motion, which, following debate, was negated on division.

*Standing order 1 was amended on 23 July 2025 to introduce a one hour time limit on the whole debate for other debates not otherwise provided for, which includes debate on a take note motion.*

*The duration of each answer during Question Time is limited to three minutes. After the maximum period allowed for a member's speech has expired standing order 1 provides that, on motion determined without debate, the member may be allowed to continue a speech for one period not exceeding 10 minutes, provided that the extension shall not exceed half of the original period allotted.*

# Committees

## 2.14 Membership of certain committees

On 25 August, the Deputy Speaker informed the House that on 8 August 2025 the Speaker received written advice from Ms Boele and Dr Scamps withdrawing their membership of certain committees. The House then resolved that Ms Boele be discharged from the Standing Committee on Climate Change, Energy, Environment and Water; and Dr Scamps be discharged from the Standing Committee on Health, Aged Care and Disability.

Both members had been appointed to these committees in excess of the limits of crossbench positions defined in standing order 215, which was amended on 26 August (see Digest 2.04).

On 27 August, the House resolved that Ms Boele be appointed to the Standing Committee on Climate Change, Energy, Environment and Water (and another committee); and that Dr Scamps be appointed to the Standing Committee on Health, Aged Care and Disability.

*Standing order 229(b) provides that if the House is not sitting, and not expected to meet for at least two weeks, membership appointments and discharges can be nominated to the Speaker in writing, with the change in membership to take effect from the time the Speaker receives the written nomination. At the next sitting, the Speaker reports the change to the House and the House resolves the membership of the committee.*

## 2.15 Joint committee resolution of appointment amended

On 26 August, the House resolved that the resolution of appointment of the Parliamentary Joint Committee on the National Anti-Corruption Commission be amended and that a message be sent to the Senate requesting its concurrence.

The amendment provided the Committee with the power to consider and make use of evidence and records of the former Parliamentary Joint Committee on the Australian Commission for Law Enforcement Integrity and the former Parliamentary Joint Committee on the National Anti-Corruption Commission appointed during previous Parliaments.

The Senate considered the message and concurred with the resolution later that day.
