#### POLICY COSTING - ELECTION CARETAKER PERIOD

### **Costing overview**

This proposal is expected to decrease the underlying cash and fiscal balances by \$54.5 million over the 2013-14 Budget forward estimates period. The financial implications of this proposal would also extend beyond the forward estimates period with a financial impact of \$17.5 million in 2017-18, bringing the total cost of the proposal to \$72.0 million over four years. This impact is entirely due to an increase in expenses.

No additional funding has been included for departmental administration costs as:

- provision of funding to States and Territories would involve a simple transfer of funds, and
- the administration of the marginal increase in community care funding could be met from within existing resources of the Department of Health and Ageing.

This costing has a number of components which are included at Attachment A.

The estimates in this costing differ from those presented in the applicant's costing request because costs totalling \$12.0 million over four years have been included for developing model legislation and providing information and awareness for patients, as per further advice from the requestor.

This costing is considered to be of high reliability as it is based on capped amounts specified in the costing request as well as further information provided to the PBO.
