PARLIAMENT HOUSE ART COLLECTION GENERAL CONDITIONS FOR USE

Image/s will be supplied ONLY on the basis that the user abides by the following conditions:

To ensure obligations that attach under Moral Rights Act (2000) are met;

- the image of the artwork/s is/are not to be cropped or overprinted in any way (although you may exclude the frame or display plinth);
- the colour range or balance of the image/s is/are not to be altered without prior written permission; and
- the full and correct title and credit details are to appear in an appropriate position in relation to the image/s to identify the work and source of the image/s. The credit line/s will be provided together with confirmation of reproduction and permission fees.
- If Parliament House Art Collection (PHAC) is not the sole owner of intellectual property
 rights in the image/s, no image will be supplied until after written evidence is received by
 PHAC that the artist has agreed to the specified use of the image. (In many cases PHAC will
 be able to supply contact details for alternate or co-owners of intellectual property rights,
 however, each case will have to be considered on a case by case basis.)
- The PHAC is to be sent for our archive, at no cost to the PHAC, ONE copy of the publication (or FIVE copies of smaller items such as brochures or cards) in which the image appears.
- Any electronic scanned image supplied or taken from transparency supplied is to be wiped off your data banks immediately after it is used for the preparation of the above publication (excluding where specific written permission has been given for digital use).
- Special conditions apply to the digital use of images, both in terms of digital recording and transmission. PHAC requires that, if permission is used for electronic use images are to be 72 dpi and/or 'watermarked' to appropriate standards. Technological limiters should apply.
- Please note that according to the *Copyright Amendment (Digital Agenda) Act 2000* unauthorised commercial use of artists' work can result in substantial criminal penalties and civil damages.

Permission for changes to any of the above conditions must be sought and <u>permission</u> <u>received in writing</u> before any changes are undertaken. Any breaches of the above conditions will result in revocation of all permissions for use.
