My wife was born in Albania, however under Article 10 of Albanian Law 8389 of 1998 (Citizenship Law), in order for me to apply for Albanian citizenship by naturalisation I would need to have lived continuously and lawfully in Albania for at least one year. I have never spent more than approximately 10 days visiting Albania and are therefore not eligible to apply for Albanian citizenship. The Honorary Consul-General for the Republic of Albania has advised that as I have not satisfied the preconditions of Article 10 I am in no way eligible.
