Quality of Care Amendment (Minimising Use of Restraints) Principles 2019 [F2019L00511]

Thank you for your letter of 20 November 2019 to the Senate Standing Committee on Regulations and Ordinances in relation to the above instrument.

The committee welcomes your undertaking to amend the Quality of Care Principles 2014 to provide for a review of the operation of the provisions inserted by the instrument after 12 months, and to repeal the provisions after two years.

On the basis of your advice, and the registration of the Quality of Care Amendment (Reviewing Restraints Principles) Principles 2019 [F2019L01505] in accordance with your undertaking, the committee has concluded its examination of the instrument.
