Gross malpractice, covered up once they set themselves on a course of vengeance against my sister.

They were determined to carry out reprisals using the children as a weapon once their grievous error was pointed out and Minister was contacted by a member of Parliament who threatened to embarrass the minister publicly.

It was only the members intervention that help get the children back into the family's care.

I was denied care of the children, despite that wish clearly being expressed in front of the Social Workers and police. Quote: "We did want to know if you would take the kids overnight, but now that you're being difficult, that wont happen!". I am the aunt and a qualified and experienced Social Worker, Court-approved Access Supervisor, Mandated Notifier and former employee of the department. I was also a Research officer for a Member of the Legislative Council at the time.

#### Financial short and long term impact of the care proceedings and forced removal:

The family (of 5) was uprooted from and forced to live 400km away and move in with my brother and his family of 6. This was to protect my sister from any further allegations of abuse or neglect which the Social Workers c/would have manufactured to bolster their chances in court. It was to give her constant supervision and contact with all her children (to prevent their trauma and distress being exacerbated). This took place over 3 months and almost damaged the relationship between the two families as the whole situation was so overthe-top outrageous.
