The department refused to ever listened to anything positive and never allowed the court to hear the positives.

Myself, older children and health workers all believe that my recovery would have been made much easier if i had of been given direction, support, encouragement, hope and options.

i take full responsibility for my actions however the cruel actions of docs and the emotional and mental abuse made it at time impossible to believe and fight.

Every day is a struggle. Constant pain and guilt and frustration; not being able to do anything about DOCS abuse, lies and corruption. They are so powerful yet not accountable to anyone.

I believe where there is evidence of abuse then yes, a child deserves better but in my case and so many others our children are removed based on a person's opinion and probability rather than evidence.

They have acknowledge my case has been handled wrong and have said i am not a risk to any child but are not willing to change anything, not even more contact.

And shockingly, they are still pushing for an adoption.

I've had workers tell me that if i had the money that my son would be home. it's so very sad to all involved that my son, myself, his brothers and all family members are suffering due to a lack of finance.

A child is not a piece of property to own and control. I would like my son home.

I have worked hard on myself.
