They never came to me to offer any support services, they failed to believe the truth, nor did they want to. There was never any follow up investigations after removal of my daughter at all.

Their policy portraying that they keep families together is a fallacy & based upon propaganda. It is not based upon the 'best interests of the child' but profits.

Child protection workers MUST be registered to work with children as other departments are that deal with children's matters.

Child Protection is running rampant without anyone holding them to account for all their failings, including failing of duty of care, abuses, neglect & deaths in care as well as the ongoing corruptions & cover-ups within their departments.

They destroy many lives & the family unit which is the core of society, they do not abide by their own policies & procedures at all.

They make up their own rules, They are not willing to put money into restoration schemes to have children rightfully returned, rather spend it on foster carers & NGO's.

They accuse the parents of wrongdoings without proof or fact & being guilty before being proven innocent.

They hold a child for ransom until the parents can afford to have them returned.

No thorough investigations are done; affidavits & reports are falsely made for court & based mainly on hearsay or false reports.

[They] commit perjury in court.

Make ALL child protection workers REGISTERED. close down the Children's (secret) court or have it made public with video & voice recordings within the court.

A Restoration scheme for the return of children.
