# Senator Patrick asked:

- 1. I presume there would be no prejudice to legal proceedings if you were to table the correspondence that took place between the DPP and your organisation?
- 2. I will just ask you to take this on notice: can you provide the committee with details of other incidents that have occurred where a brief has been considered but not advanced, and the circumstances over, perhaps, the last two years in which that has occurred?
- 3. I just wonder if you could perhaps do a bit of due diligence for the committee and track back to the directors and the operators and advise us as to whether or not there's another company that's been formed that may be operating in your area with the same people and, indeed, the same master if that's possible, please?

### Senator Gallacher asked:

4. Mr Kinley, can you take on notice how many prosecutions you have enacted, particularly under this provision of the act, safety management on boats – the success rate of the prosecutions and what they were for. And it would be handy to see your activity level on breach notices, too, over the last three years. Thank you.

# Acting Chair, Senator Sterle asked:

5. How can we make sure that we can minimise the chances of this ever happening again?

### Answer: (Australian Maritime Safety Authority)

- 1. There were a number of conversations between representatives from AMSA and the CDPP.
- 2. Details for maritime incidents that have occurred over the previous two years, where a brief has been considered but not advanced are outlined at **Attachment B**.
- 3. AMSA is not aware of any company being operated by the same person involved with the *Ten Sixty Six* incident. AMSA has received an application for a Certificate of Operation for a passenger vessel submitted by a person who appears to be a relative of the master. AMSA is assessing the application in accordance with relevant legislation.
- 4. Details for prosecutions and breaches over the previous three years are outlined at Attachment B.
- 5. The opening Statement provided by AMSA to the Committee at the hearing was intended to provide information on AMSA's implementation of recommendations made by the Western Australian Coroner in relation to the death of Mr Damien Mills, as well as other actions being taken by AMSA intended to prevent such tragic incidents happening in the future.

Following a review of AMSA's compliance functions and enforcement policy in 2017, a dedicated Enforcement and Inspector Support Unit was created. The Unit reports directly to the Chief Executive

Officer and has specialist resources to undertake compliance activities including detailed investigations, prosecutions and instigation of civil penalty proceedings.

Formal processes have been developed and implemented to allow other areas of AMSA to refer investigations to the unit, as required.

The unit will investigate all fatalities relating to the operation of domestic commercial vessels and will continue to work with the CDPP.

Since 1 July 2018 AMSA has assumed responsibility for all service functions under the *Marine Safety* (*Domestic Commercial Vessel*) *National Law Act* which means that AMSA's Enforcement and Inspector Support Unit will take the lead in investigating incidents under the National Law Act.
