In order to generate an estimate of long-term return, which is the internal rate of return, for the last year of the corporate plan a series of assumptions are adopted about key aspects of the business—operating costs, revenue and future capital—and they are projected out to 2040. 

Construction of the network is based on fibre service area modules, and we build the network out in stages. For this reason, parts of a suburb or SA2 area may become ready for service, while other parts are still under construction.</p> <p>For the Connecting Australia research, Alpha Beta analysed geospatial data on the nbn™ access network rollout to identify regions with high and low presence of the nbn™ access network.
