investments is a holding in The Infrastructure Fund (TIF). TIF is managed by Macquarie Fund Advisers (MFA). Gardior is the trustee of TIF.

2. In October, I received an invite from MFA to an investor day for TIF investors, to be held at Gold Coast Airport. On 31 October, I attended the TIF Investor Day.
3. One element of the TIF Investor Day was a panel of Gardior directors. This was advertised in the invite as the panel sharing their thoughts on positioning TIF to achieve the goals of portfolio diversification and growth in returns.
4. The Honourable Dr Annabelle Bennett AC SC is the independent chair of Gardior and was among the speakers.
5. Following opening remarks from each of the directors, including Dr Bennett, Dr Bennett asked if she could add further remarks. She proceeded, unsolicited, to comment on the potential for Australian Carbon Credit Units (ACCUs) across the TIF portfolio. Dr Bennett also noted that she was an independent panel member of the Independent Review of Australian Carbon Credit (the Review).
6. Subsequently, a question was asked of Dr Bennett from the audience, to the effect of 'Aren't there serious integrity issues around ACCUs at the moment?'
7. Dr Bennett responded by saying words to the effect of: 'Yes, hence the review. A group of academics have made allegations. The review will deliver its findings by the end of the year. Let's wait and see.'
8. Following the TIF Investor Day, I asked a colleague who was also in attendance whether they agreed with my recollection of Dr Bennett's comments. They shared my recollection. I also sent an email to two colleagues about the comments, which served as a contemporaneous note. I have revisited the contents of that email in preparing this statutory declaration.
