(6) information available to consumers about IP and TPD insurance in the context of other rehabilitation schemes.

Question—put and passed.

5 CORPORATIONS AND FINANCIAL SERVICES—PARLIAMENTARY JOINT COMMITTEE—REPORT—STATEMENTS BY MEMBERS—MOTION TO TAKE NOTE OF DOCUMENT—REFERENCE TO FEDERATION CHAMBER

Mr Irons (Chair) presented the following document:
