We have an online tabled documents project. That project is designed to deliver a facility for the executive government to submit documents for tabling in electronic format, under embargo, before the tabling date, which will then enable us to publish those documents immediately upon tabling. We're also looking at introducing a Senate division recording system for the Senate that's akin to the system that has been introduced in the House of Representatives. That system is one which will enable us to tally our divisions electronically on iPads in the chamber.
