**RE: Attorney-General's Portfolio appearance at Budget Estimates hearing**

Thank you for your letter of 14 February 2022, advising of specific information that Opposition Senators have requested be made available at the upcoming Additional Estimates hearing on 15 February 2022.

**The number and levels of staff currently employed by AGD**

As at 31 January 2022, the Attorney-General's Department (the department) employed 1906 employees. This number excludes casual employees, employees on long term leave, contractors, labour hires and secondees.

Please find **attached** an update on the implementation of the Government's response to recommendations of the Respect@Work National Inquiry into Sexual Harassment in Australian Workplaces, including Recommendation 17 and Recommendation 18.

### Details of all costs incurred by AGD, in relation to the prosecution of Witness K and Bernard Collaery to date (including AGS and external legal services)

As at 31 January 2022, the external legal costs incurred by the Commonwealth in the prosecutions of Witness K and Mr Collaery total approximately \$4,232,569.20 excluding GST.

The amount includes the services of the Australian Government Solicitor and external legal services such as counsel fees and legal disbursement costs. This amount includes the external counsel costs incurred by the Commonwealth Director of Public Prosecutions (CDPP) but does not include the CDPP's internal staff costs.

### Details of all costs incurred by AGD since the conclusion of the case against Witness K, and hence which relate only to the continued prosecution of Bernard Collaery since that time

Between 19 June 2021 (the day after Witness K was sentenced) and 31 January 2022, the external legal costs incurred by the Commonwealth in relation to the prosecution of Mr Collaery total approximately \$424,642.38 excluding GST.

The amount includes the services of the Australian Government Solicitor and external legal services, such as counsel fees and legal disbursement costs. This amount includes the external counsel costs incurred by the Commonwealth Director of Public Prosecutions (CDPP) but does not include the CDPP's internal staff costs.

**Details of AGD's knowledge of, and any advice the Department provided the current of former Attorney-General in relation to, the \$100,000 donation made to the LNP by Geoffrey Thomas the day before the Government announced that Justice the Hon David Thomas had been appointed as President of the Administrative appeals Tribunal**

At the time of Justice Thomas's appointment in 2017, the department was unaware of any political donation made by his brother. As a result, the department did not provide any advice to the then Attorney-General about the donation.

On 27 January 2022, the department advised the current Attorney-General's Office that the Administrative Appeals Tribunal had responded to a media enquiry received that day from The Australian about the political donation.

**Details of the recipients, precise purpose and timing of distribution of funds announced by the Attorney-General on 11 May 2021 in a joint Media Release titled**

**"Budget Delivering for Australian Women"**

**(<https://ministers.pmc.gov.au/payne/2021/budget-delivering-australian-women>) in relation to the following specific announcements:**

- o **"... \$129.0 million in additional legal assistance funding to women's legal centres to help women access justice. This funding will be directed to women's legal centres, to enable these providers to respond to increasing demand for domestic violence assistance";**

Through the 2021-22 Budget, the government provided additional funding of \$128.992 million over four years for legal assistance providers in each state and territory to increase their capacity to deliver services to women, including those experiencing, or at risk of, family violence. This funding is being delivered through the National Legal Assistance Partnership (NLAP).

The funding is for the delivery of dedicated legal assistance services to women. The eligible recipients of the additional funding are community legal centres, legal aid commissions, and Aboriginal and Torres Strait Islander Legal Services. The Commonwealth has required states and territories to allocate some of this funding to community legal centres specialising in the delivery of services to women.

Payments of the additional funding have been made to all states and territories. These payments were made on 7 September 2021, 7 October 2021 and 7 November 2021. The timing of these payments was determined by when each jurisdiction signed the amendments to the NLAP required to deliver the funds. The final payment for 2021-22 is expected to be made on 7 April 2022, following the receipt of Jurisdictional Performance Reports on 11 March 2022.

Under the NLAP state and territory governments determine the allocation of the funding to individual service providers. States and territories were required to submit a progress report on 30 November 2021 with projected allocations to legal assistance providers. At that stage some states and territories had not determined precise funding amounts to service providers. Actual allocations will be confirmed in further Jurisdictional Performance Reports due on 11 March 2022.

The table below sets out projected state allocations for 2021-22 for increased legal assistance for vulnerable women, as reported at 30 November 2021. Please note, some states, including NSW, were undertaking procurement processes at the time of reporting and were not able to fully report on the projected allocation. The department has requested updates from NSW about its allocations, but has not yet received that information.

- o **“More than \$60.8 million will fund the reform of family law case management in the federal family courts to improve outcomes and better meet the needs of families and children.”**

In the 2021-22 Budget, the Government provided additional funding of \$60.8 million over four years to the Federal Circuit and Family Court of Australia (FCFC). The purpose of the funding is to enable the courts to give effect to a new approach to managing and resolving family law cases. This new approach is designed to significantly shorten the time separating families spend in litigation, and increasing access to alternative dispute resolution (ADR). The FCFC has announced that its primary target is to resolve more than 90 per cent of family law cases within 12 months.

The funding supports the engagement of additional non-judicial staff, including Registrars, Family Consultants, Indigenous Liaison Officers (ILOs), and legal and administrative support staff. A comprehensive recruitment process has been undertaken by the FCFC for all the positions funded under this measure.

Key features of the new case management model include:

- o Registrars triaging cases into appropriate case management streams at the front end of the litigation process (eg: hearings before judges, ADR, specialist lists)
- o A specialised Central Assessment Team centralises the processing of over 106,000 family law applications per annum, enabling nationally consistent case management through the assessment and triaging of matters. This will support the creation of a single point of entry into the federal family law courts, as part of the establishment of the FCFC.
- o Registrars conducting ADR conferences for appropriate family law matters to settle or narrow issues in dispute, with increased use of family consultants for the more challenging parenting

matters.

- o Senior Registrars with delegated judicial powers hearing and resolving interim and procedural applications.
- o Increased use of ILOs to assist Aboriginal and Torres Strait Islander Australians navigate barriers to accessing the family law system. This includes building relationships, referrals, preparing cultural reports and delivering culturally-appropriate programs.

Further questions about the implementation of this measure would be most appropriately directed to the FCFC.

The *Parliamentary Business Resources Regulations 2017* (the Regulations) set out the eligibility criteria for a Minister to receive legal assistance.
