At the February 2016 Additional Estimates hearing, Senator Joe Bullock requested the department provide a detailed breakdown of expenditure relating to meetings of the Agricultural Industry Advisory Council (AIAC) prior to each Rural and Regional Affairs and Transport Legislation Committee hearing.

A summary of costs for AIAC meetings held between January 2014 and September 2017 were previously provided to the committee. The last report was provided on 18 October 2017. Since then the AIAC has not met.

A summary of implemented Agricultural Competitiveness White Paper measures was provided to the committee prior to the Supplementary Estimates in October 2017. Since then, the National Water Infrastructure Development Fund measure is now the responsibility of the Minister for the Department of Infrastructure, Regional Development and Cities. The current status of individual measures is provided at Attachment A.

I trust this information is of assistance in supporting the committee's preparations for its next hearing.
