\$20M Regional Jobs and Investment Package on Track

19 January, 2017

THERE'S momentum behind the scenes on the Coalition Government's \$20 million Regional Jobs and Investment Package with an announcement on the membership of the Local Planning Committee expected very soon, Leichhardt MP Warren Entsch says.

This RJIP, announced during the 2016 election, aims to diversify regional economies, create jobs and invest in sustainable regional communities and will be delivered across 10 regions nationally, including the Cairns and Douglas local government areas.

The Package will be driven by local communities who know their region best, and structured around three funding streams:

- Business innovation grants
- Local infrastructure projects
- Skills and training programmes

"The Local Planning Committee is being established to develop our regional 'investment plan'," Mr Entsch said. "We must invest our funding wisely and get the best bang for our buck, the investment plan will identify our region's strategic priority sectors and the best opportunities for growth.

"The investment plans will be used alongside the programme guidelines to ensure that funded projects reflect local priorities.

"I've been working with the Minister for Regional Development, Senator Fiona Nash, over the past couple of months and have recommended a number of local people who could contribute a wealth of local knowledge to the Panel. This includes experience in business, regional development, industry (including tourism and defence), community engagement, indigenous enterprise and environmental and social sectors.

"Minister Nash has narrowed down the nominees, written and invited them onto the Local Planning Committee and is awaiting all the responses before the membership is formally announced.

"I've requested an extension of the time that nominees have to respond to the Minister, given that some people may still be on leave from work or not checking emails as frequently during the summer period," Mr Entsch said.

"I look forward to making the announcement and releasing the names of the panel members with Minister Nash as soon as possible."

Once the Committee is appointed, they will meet to establish the Regional Investment Plan.

It's expected this will largely be based on work that has already been done in the region. When the Plan is signed off by Minister Nash, businesses will be able to lodge applications for funding which will be assessed by the Department of Infrastructure and Regional Development.

Guidelines for the program will be released ahead of our region's funding round opening so that local community groups, councils and business groups can begin thinking about their applications.

Minister for Regional Development Fiona Nash and Federal Member for Leichhardt Warren Entsch have today announced the members of the Leichhardt *Regional Jobs and Investment Package's* (RJIP) Local Planning Committee.

"These leaders are the drivers of their community and know their region best," said Minister Nash.

"This package will be locally-led through the Local Planning Committee in line with our vision for the future, and the Committee will nominate the sectors of local industry the package will invest in."

Minister Nash and Mr Entsch congratulated the Committee members on their involvement in the ground-breaking RJIP, which will provide never-before seen opportunities for local businesses.

"This is a really exciting step - every person on the Committee is local and brings an enormous amount of experience and expertise to the table," Mr Entsch said.

"Combined, we've got representation from a whole range of sectors—from tourism and defence to regional and economic growth, indigenous enterprise, business and employment, social and community development, health and sport, education, community engagement and environment."

The Committee, supported by the Department of Infrastructure and Regional Development, will be able to organise its first meeting as soon as practical. The Committee's role is to develop the local investment plan that will identify forward-looking strategic growth sectors that will drive economic growth and create jobs.

"Much of this work has already been done by peak local bodies such as Advance Cairns, the Chambers of Commerce and RDA FNQ&TS, so we won't need to reinvent the wheel," Mr Entsch said.

"Once the investment plan is finalised, funding across all three streams of the programme will open for applications from businesses.

"This \$20 million investment is designed to strengthen and stimulate long-term economic growth and deliver sustainable employment—something that we all know is critical if the Cairns and Douglas regions are to maximise opportunities into the future."

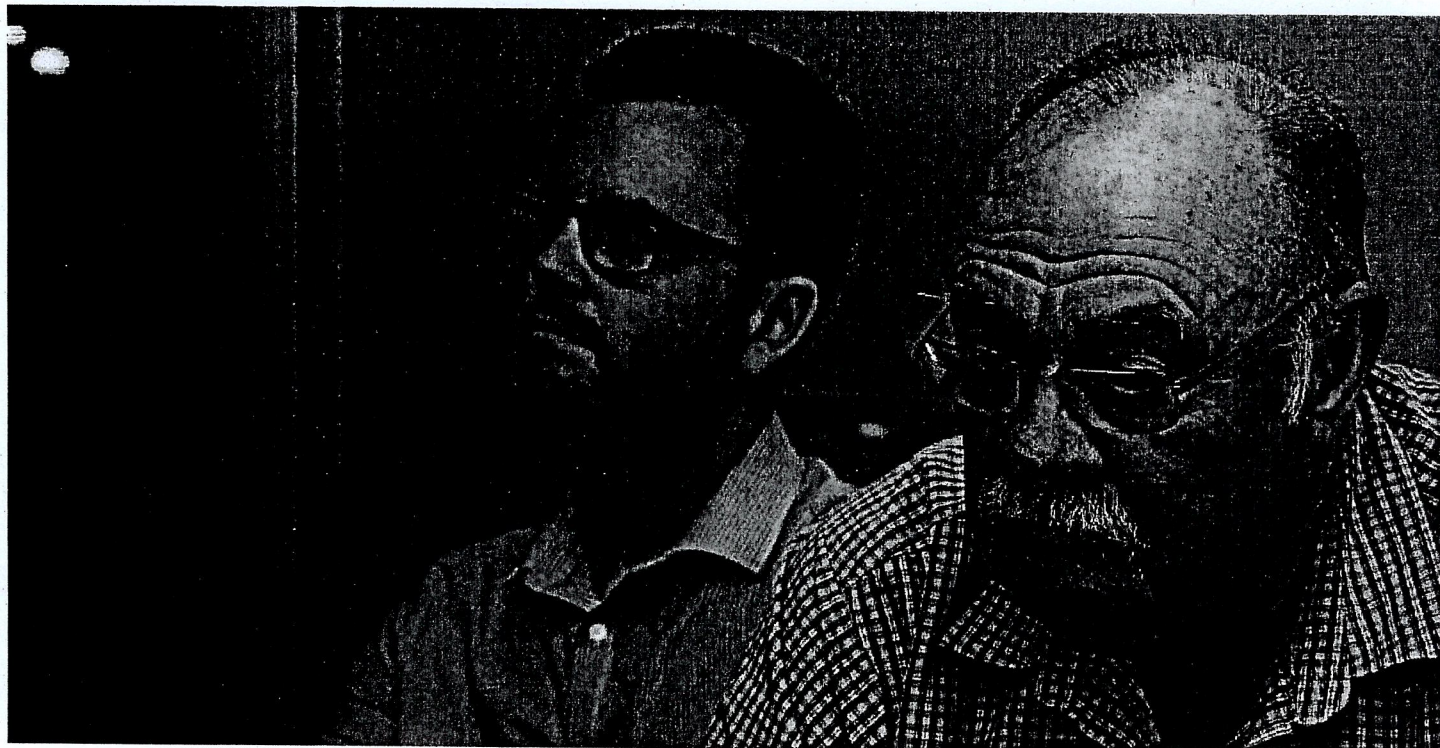

MP Warren Entsch to face queries over job funding for pharmaceutical plant

LEICHHARDT MP Warren Entsch could face a quizzing over how the wife of his campaign director Trent Twomey won a \$2.4 million federal grant to expand her family pharmaceutical empire.

Mr Entsch, whose son works for the pharmacy company behind the deal, said it was a “brilliant project” and he was outraged by suggestions “about fraud and corruption” over the \$220m Regional Jobs and Investment Package (RJIP).

“It ticked all the boxes,” he said.

Mr Entsch appointed his election campaign manager Trent Twomey, a local pharmacist and Advance Cairns chairman, to head an RJIP committee panel to identify key priorities for \$20m in federal grants to stimulate jobs growth and investment.

The shelf company QRX Group 1 – where Mr Twomey’s wife Georgina and business partner Leo Maltam are listed in company records as directors – won \$2,415,400 in funds to build a \$5m pharmacy distribution facility.

“There is nothing to disqualify it just because Trent is a pharmacist and was chair on the panel deciding the criteria,” Mr Entsch said. “Health was identified as one of the key priorities. It (the project) went down to the bureaucrats in Canberra and they signed off on it.”

The Australian Federal Police has been referred a formal complaint but are yet to launch an official “active” fraud investigation. An AFP spokesman suggested the matter might be referred to the Department of Regional Development’s internal probity and audit unit.

Business leaders and pharmacy owners said the vision to build Northern Australia’s first pharmaceutical manufacturing and distribution centre was unheard of until the grant was announced two weeks ago.

“Does it pass the sniff test? Cairns Mayor Bob Manning said. “Or the pub test?”

“Whatever, at the very least, it appears to be a matter of a potential conflict-of-interest that warrants top-level review or investigation by authorities,” he said.

Mr Twomey denied he had done anything wrong. “I’ve got absolutely nothing to hide,” he said.

A spokeswoman for Regional Development Minister John McVeigh said there was “no issue” with any of the projects in Cairns. She said they all underwent a “rigorous independent assessment process” and got final Cabinet approval.

Funding package delivers jobs bonanza for Far North Queensland

- 21 projects, creating over 1,000 jobs, will be delivered across Tropical North Queensland
- \$220 million initiative to stimulate job creation and investment in regional Australia

Tropical North Queensland businesses are the big winners thanks to a \$20 million funding and jobs boost from the Coalition Government's Regional Jobs and Investment Package.

Federal Regional Development, Territories and Local Government Minister John McVeigh joined Federal Leichhardt MP Warren Entsch at the Cairns International Tennis Centre to announce the 21 projects.

"Regional Australia is critical to our national prosperity and we are committed to unlocking its potential. This nearly \$20 million investment will support Tropical North Queensland's future and continue the Coalition Government's commitment to strengthen regional communities," Dr McVeigh said.

"Thanks to Warren Entsch's fierce advocacy we've been able to deliver for local businesses, generating more than 400 jobs during construction and nearly 650 ongoing jobs.

"This initiative is diversifying regional economies, including those that have undergone transition by creating more jobs and delivering more liveable communities and essential infrastructure."

Federal Leichhardt MP Warren Entsch said he was 'over-the-moon' the region had secured a Regional Jobs and Investment Package—one of only 10 nationwide.

He said each of the 21 successful projects were worthy recipients and would further enrich Far North Queensland communities.

"Projects like the \$4.7 million fit-out of the Cairns Aquarium will create 180 full-time jobs which will help support local families which in turn will stimulate the local economy," Mr Entsch said.

"Cairns Aquarium is already a world-class facility and major tourist attraction, but I expect it will soar to new heights thanks to this funding grant.

"The establishment of an air freight terminal at Cairns Airport is extremely exciting. It will allow us to export our region's world-class fruit, dairy, seafood and meat to domestic and international markets.

"The real winners though are our primary producers because it will allow them to export their produce through Cairns as opposed to sending it to other ports.

"Residents will also benefit from investments like the purchase of specialised and rehabilitation equipment at Spinal Life Australia's Healthy Living Centre in Cairns, the construction of a dedicated Residential Aged Care Centre in Mossman and delivering the Northern Beaches Leisure Trail—an iconic recreational shared use path from Palm Cove to Cairns CBD."

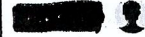

Prime Minister tours Cairns innovation hub to reveal jobs plan

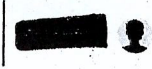

PRIME Minister Malcolm Turnbull has tried to sell his \$20 million jobs plan directly to a group of the Far North's most innovative small businesses during a whirlwind visit to Cairns.

The *Cairns Post* yesterday revealed Mr Turnbull's plan to tackle the city's unemployment woes by offering \$20 million worth of grants to Cairns businesses to encourage them to hire more staff.

He said the fund, which would be administered by the Federal Regional Development Department, would be managed closely with Advance Cairns and Cairns Chamber of Commerce with Leichhardt MP Warren Entsch also involved in the decision-making process.

Their anchor release system has been designed specifically for recreational boats to minimising damage to fragile reefs.

While the system is already manufactured in Australia at Adelaide, Mrs Powell said the Coalition's proposed business grants could help them shift manufacturing to Cairns.

"It's been a dream of ours to set it up to manufacture them locally and employ people here in Cairns," she said.

"When you want to expand, sometimes it's just a little bit out of your reach so matched government funding would be such a big help."

Founder of theSpace Damian Zammit welcomed the Prime Minister and his jobs plan during a tour of the facility yesterday and flagged close future collaboration with James Cook University's planned Cairns Innovation Centre.

\$20m jobs plan to be delivered

A LONG-AWAITED \$20 million jobs package for the Far North will finally be delivered by the end of January after months of administrative setbacks caused by the federal citizenship scandal.

Prime Minister Malcolm Turnbull said the Regional Jobs and Investment Package for businesses in the Cairns, Douglas and Yarrabah local government areas was on the verge of being finalised.

"We announced the Geelong one earlier in the week," he said.

"It's coming, don't worry, you'll get there.

"I must say, they've put a lot of effort into making sure the projects chosen are the ones that are going to deliver the best bang for the buck."

Leichhardt MP Warren Entsch said departmental staff had assured him the successful projects for the dollar-for-dollar grant scheme would be named before February.

"We were oversubscribed ... we put up \$20 million and we got about \$45 million worth of projects," he said.

The prime minister labelled the glut of applicants "a classy problem" to have.

Geelong, which like the Far North received matched funding of \$20 million, is set to deliver more than 1200 new jobs across 21 separate organisations.

Funding shortlist finalised

THE Federal Government's long-awaited \$20 million jobs package for the Far North finally has a date set in stone for its announcement.

Leichhardt MP Warren Entsch had said the Regional Jobs and Investment Package for the Cairns, Douglas and Yarrabah regions would be finalised by the end of last month.

It followed months of previous delays blamed on the Federal Government's citizenship saga.

Regional Development Minister John McVeigh will be in Cairns to unveil the list of successful projects receiving dollar-for-dollar funding on February 21.

"I've got them pinned down to a date now," Mr Entsch said.

"The only reason it's on the 21st is because on Monday (today) Parliament goes back

for two weeks. I'll be catching up with him in the first week of Parliament to go through the final details."

Mr Entsch said he had not seen the list of projects but the full \$20 million would be spent.

"It will be spent right across the whole area so that everyone that has an interest in it

will benefit," he said.

Labor Senator Murray Watts said the long wait was unacceptable.

"Warren Entsch at the ... federal election 18 months ago had lots of talk and lots of money for a regional jobs and investment fund," he said.

"Eighteen months later, not a single job, not a single dollar has been spent."

Geelong's \$20 million portion of the package was announced last month, with 21 projects securing funding for works expected to create 600 new jobs during construction and 600 ongoing jobs.

You must notify us of events relating to your project and provide an opportunity for the Minister or their representative to attend.

12.12 Evaluation

We will evaluate the program to determine the extent to which the funded activity is contributing to the program objectives and outcomes. We may use information from your application and project reports for this purpose. We may also interview you, or ask you for more information to help us understand how the grant impacted you and to evaluate how effective the program was in achieving its outcomes. We may contact you up to four years after you finish your project for more information to assist with this evaluation.

12.13 Tax obligations

If you are registered for the Goods and Services Tax (GST), we will add GST to your grant payment and provide you with a recipient created tax invoice.

Grants are assessable income for taxation purposes, unless exempted by a taxation law. We recommend you seek independent professional advice on your taxation obligations or seek assistance from the Australian Taxation Office. We do not provide advice on tax.

13. Conflicts of interest

13.1 Your conflict of interest responsibilities

We manage our conflicts of interest according to the *APS Code of Conduct (section 13 (7) of the Public Service Act 1999)*. We publish our conflict of interest policy on the Department of Industry, Innovation and Science⁶ website.

Program officials must declare any conflicts of interest. If we consider a conflict of interest is a cause for concern, that official will not take part in the assessment of relevant applications under the program.

14. How we use your information

Unless the information you provide to us is

- confidential information as per 14.1, or
- personal information as per 14.3,

we may share the information with other Commonwealth or state government agencies and Members of Parliament for a relevant purpose such as

- to improve the effective administration, monitoring and evaluation of Australian Government programs
- for research
- to announce the awarding of grants.

14.1 How we handle your confidential information

We will treat the information you give us as sensitive and therefore confidential if it meets one of the four conditions below

1. You clearly identify the information as confidential and explain why we should treat it as confidential.
2. The information is commercially sensitive.
3. Disclosing the information would cause unreasonable harm to you or someone else.
4. You provide the information with an understanding that it will stay confidential.

14.2 When we may disclose confidential information

We may disclose confidential information

- to the committee and our Commonwealth employees and contractors or state government employees, to help us manage the program effectively
- to the Auditor-General, Ombudsman or Privacy Commissioner
- to the responsible Commonwealth or state government Minister or Assistant Minister
- to a House or a Committee or Members of the Australian Parliament.

We may also disclose confidential information if

Introduction

It is the Department's policy to provide a reporting framework which enables employees to disclose, and take reasonable steps to avoid, any conflicts of interest in connection with their APS employment. The policy also provides guidance for all employees on how to recognise and avoid insider trading, which is prohibited by law. This policy applies to all employees covered by the Department of Innovation, Industry and Science current Enterprise Agreement.

Principles

- An apparent or allegation of conflict of interest or insider trading can be damaging to individual employees and adversely affect the reputation of the Department and its ability to function effectively.
- Fostering an awareness of the circumstances leading to conflict of interest and insider trading is an important mechanism for avoiding such situations.
- Transparency through a continuous disclosure reporting framework is the most appropriate approach to handling these issues.
- The freedom of employees to invest and associate should not be unduly limited by their APS employment.
- The procedures should not unreasonably interfere with the privacy of employees or their families.
- If a conflict of interest becomes apparent the Department will seek to resolve this in a way which removes the conflict with minimal impact on the employee.
- In some circumstances it may be necessary to institute arrangements to protect both the employee and the Department. As a last resort, it may be necessary to reassign the employee.

Background

In the course of their duties, many of our employees have access to commercial and other sensitive information which may either pose a conflict with their private interests, or create a perception that such a conflict exists.

The APS Code of Conduct (section 13(7) of the *Public Service Act 1999*) requires that APS employees disclose, and take reasonable steps to avoid, any conflict of interest (real or apparent) in connection with APS employment. It is also in the interests of all employees that the firms and people we do business with are confident that we act in accordance with the Code of Conduct and do not make improper use of information.

Insider trading would also breach the *Public Service Act 1999* requirement not to make improper use of inside information. Furthermore, insider trading is prohibited for all members of the community under the *Corporations Act 2001* and has criminal penalties.

There is also a more general obligation under the *Public Service Regulations 1999* on employees not to disclose any information about public business or anything of which the employee has official knowledge and, under the *Crimes Act 1914*, it is an offence for an employee to publish or communicate such information.

The Department also has obligations under the *Privacy Act 1988*. These include having a reasonable basis for requiring information and securing information to ensure privacy. Further information is available at <http://www.privacy.gov.au>.

Conflict of Interest

Definition

A conflict of interest is a circumstance which places an employee in a position where their personal interests (including those of their immediate family – to the extent known) could compromise their independence. Apparent (or perceived) conflicts of interest may be as important as actual conflicts.

Recognising potential conflicts of interest

Employees should consider whether any of their private interests, such as personal relationships and financial interests (including those of their immediate family), could be affected by the decisions of the Department over which the employee has influence.

An employee who is unclear whether particular circumstances constitute (or may in the future constitute) an apparent conflict of interest should discuss the matter with their Manager, General Manager or Head of Division in a timely manner, to clarify matters and ensure appropriate procedures are followed. This is an important protection, both for the reputation of the Department and the employee, and would help to provide a response to any subsequent allegations of misconduct.

Immediate family

For the purpose of this policy, an employee's immediate family is defined as the employee's spouse/partner and/or children. The obligation on employees to disclose the private interests of their immediate family is limited by the extent to which the employee can reasonably be expected to know such interests and the consent of the relevant family member(s) to disclose any personal information.

Personal Relationships

Employees may have personal relationships (including family and friendships) with people who are engaged in activities that could have an interest in issues with which the employee deals or over which the employee has influence. Examples could include journalists, lobbyists (see below) or people who have business dealings with their agency. APS employees are, of course, perfectly entitled to have such relationships. However, in the interests of transparency, employees should disclose the names and activities of any persons who could be seen to impact upon the employee's responsibilities.

Relationships with lobbyists

Employees need to be aware of and manage any real or apparent conflict of interest between their official duties and their relationships with lobbyists, including personal or social relationships with lobbyists.

The Lobbying Code of Conduct sets out the Government's policies for all APS employees in relation to contact with professional lobbyists and seeks to ensure that such contact is conducted in accordance with public expectations of transparency, integrity and honesty. All APS employees should familiarise themselves with the requirements of the Lobbying Code of Conduct. Any lobbyist who acts on behalf of third-party clients for the purposes of lobbying Government representatives must be registered on the Register of Lobbyists.

Acceptance of gifts

Employees are expected to apply high standards of probity and ethical behaviour when accepting gifts or benefits (Accountable Authority Instructions 2.4 refer). Gifts or benefits should not be accepted by an employee or a member of their immediate family if acceptance could, in any way, be construed as an attempt to influence an administrative, regulatory or contractual decision, or create the appearance of a conflict of interest.

If an employee has any doubts about the propriety of accepting a gift or benefit, then the gift or benefit should not be accepted, or the matter raised with their Disclosure Officer for guidance.

Insider Trading

Definition

Insider trading is trading in shares or other financial products (including procuring or inducing another person to buy or sell such products) on the basis of inside information. Inside information is information which is not generally known and which, if it were generally known, could reasonably be expected to have a material effect on the value of the particular financial product. Insider trading is prohibited by the *Corporations Act 2001* and has criminal penalties. Insider trading would also breach the *Public Service Act 1999* requirement not to make improper use of inside information.

Recognising 'insider trading' information

Employees should be aware that the information they access as part of their duties may be inside or commercially sensitive information. Employees must not trade in shares or other financial products, or induce others to do so, on the basis of such information. It is the responsibility of each employee to form a judgment as to whether the information they access in the course of their APS employment would be considered inside material information.

Key considerations include:

- Is the information publicly available?
- How was the information obtained – was it provided with a 'commercial-in-confidence' or 'in-confidence' classification?
- Do you believe knowing the information would be 'getting in early' ahead of the investment market more generally?
- Would you expect the information to have a material effect on the value of the particular financial product?

Employees in some areas may have access to material information relating to companies in sectors outside of the Industry and Science portfolio. It is important to note that the absence of direct policy or program responsibility would be no defence to an insider trading allegation.

Management Framework

Procedure for continuous disclosure of private interests

All employees are required to follow the department's procedures for the continuous disclosure of private interests by completing annual declarations (compulsory) and subsequent declarations throughout the year (as required).

A self-assessment test for non-SES employees to assist in determining relevant private interests is provided below. This test can assist employees to determine their obligations with regard to the disclosure of private interests at any time of the year, not just for annual declarations.

Making declarations

- Each year, SES employees are required to complete a Conflict of Interest Declaration form, located in ESS Aurion.
- Acting SES employees should complete a SES declaration form during their period of acting, in addition to any declarations they may have disclosed as non-SES employees.
- All non-SES employees should consider whether they have anything to disclose after watching the Awareness Tutorial located on the Conflict of Interest intranet page. Should employees need to disclose, they can do so by logging in to ESS Aurion and completing a Conflict of Interest declaration form.
- New employees must consider completing a declaration on commencement.
- Employees who have transferred between Divisions should consider whether they have anything to declare within 4 weeks of commencing in a new Division.

Disclosure Officers

- Disclosure Officers for SES / Heads of Divisions is the relevant Deputy Secretary and the Secretary is the Disclosure Officer for the Deputy / Associate Secretaries.
- For all employees with a classification up to and including EL2, the Disclosure Officer will be the employee's General Manager.
- Managers are not Disclosure Officers but will assist with the assessment of disclosures where necessary.

Storage and security of declarations

All declarations are stored electronically and are reported to the Disclosure Officer to ensure Conflicts of Interest (real or apparent) are appropriately managed.

Managing conflicts of Interest

The Disclosure Officer is responsible for assessing declarations and determining whether a real or apparent conflict of interest exists and whether any such conflict is material or immaterial. Managers assist the Disclosure Officer by obtaining and providing relevant information. In the event that a real or potential conflict of interest is identified, the employee will be advised of any actions required to manage the conflict.

Intention to trade in financial products relevant to the Division

It is also required that, before making any trades (either purchase or sale) of financial products related to the policy or operational responsibility of the employee's division, the employee should discuss the matter with the relevant General Manager. This includes trading by the employee and by the employee's immediate family (to the extent known by the employee). Employees are reminded that such proposed trading may give rise to potential conflicts of interest or insider trading and early discussion with the relevant General Manager is encouraged. Employees should note that any such discussion shall not be construed as the provision of investment advice or recommending one course of action over another. The purpose of the discussion will be to explore the principles of conflicts of interest and insider trading as they may apply to the proposed trade.

After leaving the Department

On leaving the Department, all employees are reminded of their obligation to not disclose, or act upon, information gained as a result of their employment with the Department. The only exemption would be when such information is publicly available.

There are additional restrictions on post-separation employment by SES employees who leave the APS after 1 July 2008 whereby they shall not, for a 12 month period,

engage in lobbying government representatives on any matters on which they have had official dealings as public servants over their last 12 months of employment.

More information on post separation employment can be obtained from the Australian Public Service Commission website.

Boards and Committees

Government boards and committees play an important strategic role in providing leadership, direction and accountability across the public sector.

There are many types of government boards and committees including:

- boards of public trading enterprises
- boards of statutory authorities
- policy coordination committees
- research committees
- tribunals
- registration boards
- appeal boards
- public trusts
- advisory committees.

The potential exists for conflicts of interest for duty in committees or boards established by the Department, particularly where a Minister appoints the chair and/or members and the committee or board can significantly influence decisions.

It is important for Divisions to establish procedures to alert committee members to the need to identify and avoid conflicts of interest. This may include committee members providing written declarations of interests that relate to activities of the committee, and making conflicts of interest a standing agenda item for committee meetings.

This policy together with the existing processes in AusIndustry can be used as guides in developing appropriate arrangements for committees and boards.

Job scheme facing audit

Probe follows funding decision concern

THE Turnbull government's flagship \$220 million regional jobs scheme faces a top-level national audit after probity concerns of pork barrelling in a multimillion-dollar handout to a drugstore company in Cairns.

Australia's Auditor-General has detailed plans to order an independent investigation into the entire Regional Jobs and Investment Package (RJIP) program rolled out across 10 pilot regions from Far North Queensland to Tasmania.

The Auditor-General Grant Hehir told how his decision follows concerns about a potential conflict of interest and shortfalls in a project awarded \$2.4 million by the RJIP to a company which the wife of the former campaign director of Leichhardt MP Warren Entsch is a director.

Under the proposed audit, the Australian National Audit Office will scrutinise the handling of all of the 232 projects

funded by one of Prime Minister Malcolm Turnbull's pet "jobs and growth" schemes.

"The ANAO continues to have a focus on promoting transparency on the effective use of taxpayers money," Mr Hehir said, in a letter to Labor MP Stephen Jones who referred the matter to the Auditor-General. "It is in this

context that I have noted your concerns in the RJIP."

He said the scope of the audit would "include the application, assessment and decision-making processes".

The Australian Federal Police yesterday also confirmed they had finalised a month-long probe into an individual complaint of alleged fraud and official misconduct over the handling of the \$2.4 million RJIP grant in Cairns.

"The AFP did not identify any commonwealth criminal offences," a spokesman said.

The *Cairns Post* exclusively revealed how civic and business leaders questioned if the taxpayer-funded grant "passed

the pub or sniff test" when Mr Entsch appointed his ex-LNP campaign director and Advance Cairns chairman Trent Twomey to head the local RJIP steering committee.

Both Mr Entsch and Mr Twomey claim they have "nothing to hide" over the decision to award \$2.4 million to QRX Group 1 – one-third owned by Mr Twomey's wife – to expand the family's pharmaceutical business.

Regional Development Minister Dr John McVeigh's spokeswoman said they welcomed the top-level investigation and described it as "routine practice".

Under the RJIP scheme – an election promise that took two years to roll out – the taxpayer funded grants partnered with businesses, councils and community organisations on projects in tourism, agriculture, sport, manufacturing, health and technology.

It is touted to deliver more than 11,000 jobs and leverage \$687 million in investment.

\$2.4m for new drugs industry

IT WAS touted as Northern Australia's first pharmaceutical distribution and manufacturing centre spawning an entirely new industry for Cairns.

QRX Group 1's director and one-third shareholder Leo Maltam says the \$5 million project will create 80 full-time jobs during construction and another 20 ongoing positions once operational.

Hi-tech and expensive robotic systems will conduct automated compounding — the preparation of highly specialised drugs such as injections, chemotherapy and eye drops — cutting out the middlemen down south.

But industry insiders have raised serious questions about how QRX came to receive \$2.4 million in federal funds.

Mr Twomey, who was chairman of the committee that set up the criteria for the \$20m regional jobs package, said he was unaware of any federal police inquiries into the matter until he was contacted by the *Cairns Post*.

"No one's ever called me about any of this, no one's ever spoken to me about any of this, you're the first person to raise it with me," he said.

Cairns pharmacist Mario Calanna characterised Mr Twomey as an enigmatic and driven businessman with influence across Australian political circles.

"It's hard to dislike Trent but he's got some insatiable energy," he said.

"When he decides to do something, he just doesn't care who he runs over, he just does it."

Mr Calanna raised concerns about QRX gaining federal funds when Mr Twomey's wife, Georgina, was a one-third shareholder of the company.

Other Pharmacy Guild members were cautious about speaking out, but questioned whether the 20 new jobs described when the Federal Government approved the project would be genuinely new or just reshuffled from existing pharmacies.

It is understood Mr Twomey and his business partners plan to de-brand their pharm-

acies to be reopened under a unified banner to reduce overheads and fees currently paid to franchises including Terry White and Good Price.

Mr Twomey did not respond when asked about the rebranding plans.

Having an off-site manufacturing centre at their disposal would mean on-site packaging and distribution operations could be reduced at individual pharmacies.

"They would need less people anyway because a machine is actually doing the packaging," Mr Calanna said.

"One person might be able to do eight or 10 (packets) an hour.

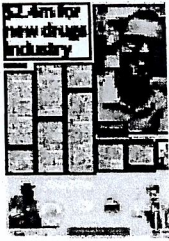
"A machine will do unlimited, basically.

"If you go from Point A to Point B, it's a new job isn't it?"

"But Point A doesn't exist anymore."

Mr Maltam said bookkeeping operations would also be conducted at the new centre.

"The core function of the facility is to bypass the southern pharmaceutical wholesalers and enable local pharmacies to deal directly with domestic and

international drug manufacturers," he said.

"The central distribution of prescription and non-prescription drugs via state-of-the-art robotics will enable greater workflow efficiencies to be passed onto pharmacies and ultimately the patients."

Mr Maltam said the facility would be established in Cairns, but he was still carrying out due diligence on several potential sites.

"My plans are for construction to start this year with completion next year," he said.

Mr Maltam was asked on February 22 whether he was QRX's sole operator, or if there were other backers involved.

"I am the sole operator," he responded via email.

Subsequent company searches reveal two more shareholders with equal interests in the venture — T&A Walters Investments and Georgina Clare Twomey.

It has also emerged QRX is one-third shareholder in Tropic Group Pty Ltd, the company behind former LNP Member for Cairns Gavin King's news publication *Tropic Now*.

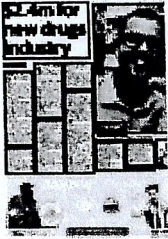

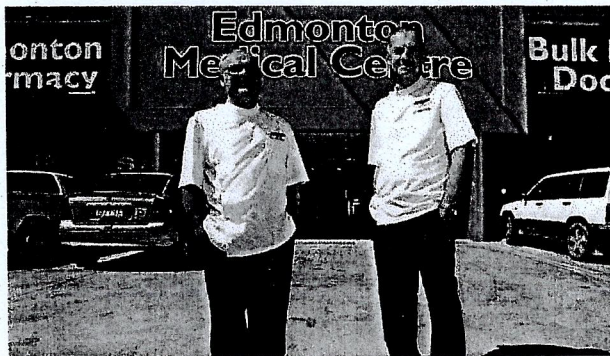
