

# Senate Environment and Communications Legislation Committee Budget Estimates 2024–25 Thursday, 30 May 2024 Daily Summary

The committee met from 9.00am until 9.18pm.

The committee called the following departments and agencies:

- Department of Infrastructure, Transport, Regional Development, Communications and the Arts (DITRDCA)
- Office of the eSafety Commissioner
- Australian Broadcasting Corporation
- Australian Communications and Media Authority

#### DITRDCA – Corporate matters and general questions

- Prominence and anti-siphoning regulatory regime commencement date;
- Increases in the average staffing level over the past 2 years and the related allocation;
- Extra functions and resourcing needs across the department's communications functions;
- Departmental appropriation funding, and specifically across the communications functions;
- Progress on the preparation of online gambling legislation and deadline for implementation;
- Process of Questions on Notice (QoN) clearance between the Department and the Minister's Office;
- Prime Minister and Cabinet advice and guidance over the QoN clearance process and timeline compliance for the department and outstanding QoN answers from previous estimates rounds;
- Length of process of obtaining security clearance across the department and temporary security clearance arrangements;
- Consultation between department officials and the Foreign Affairs Minister and Trade Minister in relation to the draft local content and streaming quota legislation; and
- Meetings between United States companies and the department regarding the streaming quota legislation.

# 5.1 – Digital Technologies and Communications Services

- Timeline of the 3G network shut down and the extent of affected devices that wouldn't be able to call 000 and Industry consultation to understand the number of affected devices;
- Modelling done by the department regarding number of affected Australians impacted by the revised anti siphoning scheme and access to free to air sporting events;
- Meetings between Minister's Office and News Corp executives;
- Government response to the HOR Murphy Report on online gambling advertising and ministerial directions to the department;
- Issues with Australians still being able to place bets and gamble despite having signed onto the BetStop National Self-Exclusion Register;
- Funding allocations to the mobile blackspot program; and
- Progress on the age verification trials for online content and determinations being made on age limits for types of content.

## Office of the e-Safety Commissioner

- The role, responsibility, and powers of the eSafety Commissioner;
- Age verification trials on social media;
- Sexual extortion of children and young adults online;
- Threshold for social media posts being classified as gender based hate speech and therefore being considered harmful by eSafety guidelines;
- Online guidance for parents when supervising their children's use of social media;
- Regulation regarding generative AI, including AI generated pornographic material;
- Definition of Class 1 material; and
- Various legal proceedings between the eSafety Commissioner and X Corporation.

## Australian Broadcasting Corporation (ABC)

- Progress on the independent workplace racism review at the ABC;
- Comments made by Laura Tingle at the Sydney Writers Festival and the Melbourne Writers Festival;
- Internal surveys regarding staff renumeration by demographic;
- Rebranding of ABC channels surrounding children and family content;
- ABC coverage and journalist guidance on the developing situation in Gaza;
- Meta Corporation refusing to renew contracts under the media bargaining code;
- Staffing and news coverage in regional Australia following closure of regional news outlets;
- Environmental impacts resulting from ABC operations and initiatives undertaken to move towards its emission reduction targets;
- ABC TikTok journalists' activities in relation to coverage of Israel-Palestine;
- Funding for emergency broadcasting services for the upcoming summer;
- Parramatta office staffing levels and progress made toward having 75 per cent of ABC content makers working outside of the Ultimo office; and
- Actions of certain individual journalists that may be in contravention of the ABC code of conduct.

#### Australian Communications and Media Authority (ACMA)

- Al deepfakes using the voice and likenesses of prominent figures in Australia to promote misinformation;
- ACMA reporting on free-to-air television programs and streaming video on demand (SVODs);
- Expenditure for children's drama on free-to-air television and SVODs;
- Progress on the review of the telecommunications consumer protection code;
- Funding for the review and improvement of existing scam codes for telecommunications providers; and
- ACMA investigation into the Tangerine Telecom data breach.
