



Senate Environment and Communications Legislation Committee

Tuesday, 10 February 2026
Daily summary

The committee met from 9.01am until 11.01pm.

The committee called the Communications, Sport and the Arts portfolio and discussed the following topics:

- Grants given to artists; and
- Ongoing operations of Music Australia.

Screen Australia

- Production of the documentary 'Silenced'.

Outcome 6: Participation in, and access to, Australia's arts and culture through developing and supporting cultural expression - Program 6.1 – Arts and Cultural Development, Office for the Arts, Closing the Gap Outcome 16: First Nations Languages

- Funding for the Commonwealth Indigenous Languages and Arts Program.

The Committee made the decision to question both Outcome 7 of DITRDCSA and the Australian Sports Commission at the same time for timing purposes

Outcome 7: Contribute to healthy, active communities and a sustainable sport system through policy development, coordination and targeted support - Program 7.1: Sport and Physical Activity Australian Sports Commission (Australian Institute of Sport)

- Funding to National Sporting Organisation's;
- Preparations for the 2032 Olympics in Brisbane; and
- Funding cutoffs for sport grants for individual athletes on 30 June 2026.

The committee released the Australian Film, Television and Radio School, Australia Post, Museum of Australian Democracy, NBN Co Limited, National Gallery of Australia, National Archives of Australia and the National Museum of Australia.
