

Senate Economics Legislation Committee Supplementary Budget Estimates 2025–26 Thursday, 4 December 2025 Daily summary

The committee met from 9.00am until 10.03pm.

The committee called the Treasury and Industry, Science and Resources portfolio, discussing the following topics:
