

# Senate Rural and Regional Affairs and Transport Legislation Committee Supplementary Budget Estimates 2025–26 Tuesday, 7 October 2025 Daily summary

The committee met from 9.05am until 11.01pm.

The committee called the Department Infrastructure, Transport, Regional Development, Communications and the Arts Portfolio, discussing the following topics:
