The committee met from 9.01am until 11.01pm.

The committee called the Treasury portfolio, discussing the following topics:

- ATO treatment of small businesses;
- Enforcement in the charity sector;

- National projected debt.

Housing Australia

- Independence and governance of Housing Australia; and
- Progress of the Housing Australia Future Fund.

The committee agreed to release the Australian Bureau of Statistics from the hearing.
