**COMMUNITY CONSULTATION REPORT FOR THE CONSTRUCTION AND  
UPGRADE OF INDIRECT FIRE SUPPORT FACILITIES FOR THE LAND 17 PHASE  
1B/1C INFRASTRUCTURE PROJECT**

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) about the nature and extent of community consultation undertaken as part of LAND 17 Phase 1B/1C Construction and Upgrade of Indirect Fire Support Facilities Project (Project).

The objectives of the community consultation undertaken by Defence were to ensure that the community:

- was well informed about the Project by using effective and proven communication channels to convey details of the proposed works; and
- had every opportunity to raise issues of concern so that wherever feasible they could be addressed by Defence in its program of works.


The consultation activities undertaken included:

- Correspondence sent by email to local groups, State and Federal members and an offer of individual briefings. The members and groups consulted, with a short description of the outcomes of the engagement are detailed in Annex A. - Advertisements in local newspapers, as detailed and listed at Annex C;
- A Public Information Session was undertaken at Gallipoli Barracks as detailed at Annex D;

All contractors will be required to go through an induction process when they first attend site and will be directed to comply with it. As a result of LAND 17, will there be an increase in personnel using the Close Training Area at the back of Gallipoli Barracks?	No. The proposed project will deliver a simulation system for training soldiers. If there were any impact from the project it would see a reduction in the use of this area because of simulation. What is the timeframe for construction works at Gallipoli Barracks? (Gallipoli Barracks)	The proposed project works are forecast to commence April 2016 and are scheduled for duration of 12 months across the entire project. As this project is subject to parliamentary approval and is yet to be tendered, a construction schedule for Gallipoli Barracks is yet to be determined within the 12 month window. (Project Director - LTCOL Haertsch)	Member of the Public
